The relative strengths and weaknesses of Wohnbau GmbH Prenzlau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbau GmbH Prenzlau compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 74% points. The greatest weakness of Wohnbau GmbH Prenzlau is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 256% points.

The company's Economic Capital Ratio, given in the ranking table, is 74%, being 30% points below the market average of 104%.
