



The relative strengths and weaknesses of Stadtbau Waldkraiburg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stadtbau Waldkraiburg GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 51% points. The greatest weakness of Stadtbau Waldkraiburg GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 284% points.

The company's Economic Capital Ratio, given in the ranking table, is 51%, being 53% points below the market average of 104%.
