



The relative strengths and weaknesses of Paeschke Bauträger GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Paeschke Bauträger GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Propertysales Remainder, increasing the Economic Capital Ratio by 64% points. The greatest weakness of Paeschke Bauträger GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, reducing the Economic Capital Ratio by 162% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 29% points below the market average of 104%.
