



The relative strengths and weaknesses of Laumer Bautechnik GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Laumer Bautechnik GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 227% points. The greatest weakness of Laumer Bautechnik GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 625% points.

The company's Economic Capital Ratio, given in the ranking table, is 227%, being 123% points above the market average of 104%.
