



The relative strengths and weaknesses of Echterhoff Holding GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Echterhoff Holding GmbH Konzern compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 115% points. The greatest weakness of Echterhoff Holding GmbH Konzern is the variable Bs Ass Currass Inventory Inprogress Remainder, reducing the Economic Capital Ratio by 2.142% points.

The company's Economic Capital Ratio, given in the ranking table, is 115%, being 11% points above the market average of 104%.
