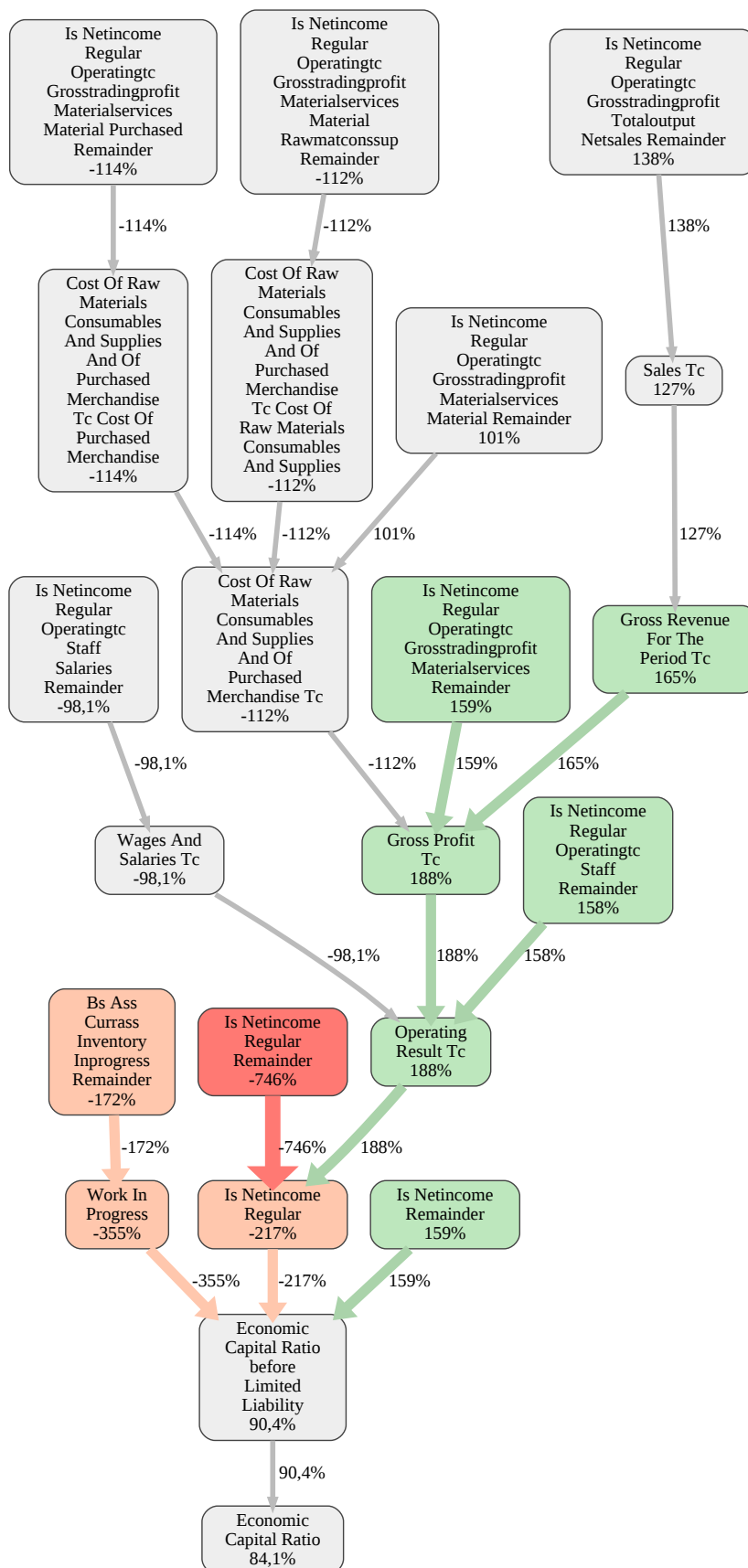




The relative strengths and weaknesses of Kramer Beteiligung GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kramer Beteiligung GmbH Co KG Konzern compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 188% points. The greatest weakness of Kramer Beteiligung GmbH Co KG Konzern is the variable Is Netincome Regular Remainder, reducing the Economic Capital Ratio by 746% points.

The company's Economic Capital Ratio, given in the ranking table, is 188%, being 84% points above the market average of 104%.
