



The relative strengths and weaknesses of Dobler Gesellschaft mit Beschränkter Haftung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dobler Gesellschaft mit Beschränkter Haftung Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 130% points. The greatest weakness of Dobler Gesellschaft mit Beschränkter Haftung Konzern is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 609% points.

The company's Economic Capital Ratio, given in the ranking table, is 130%, being 26% points above the market average of 104%.
