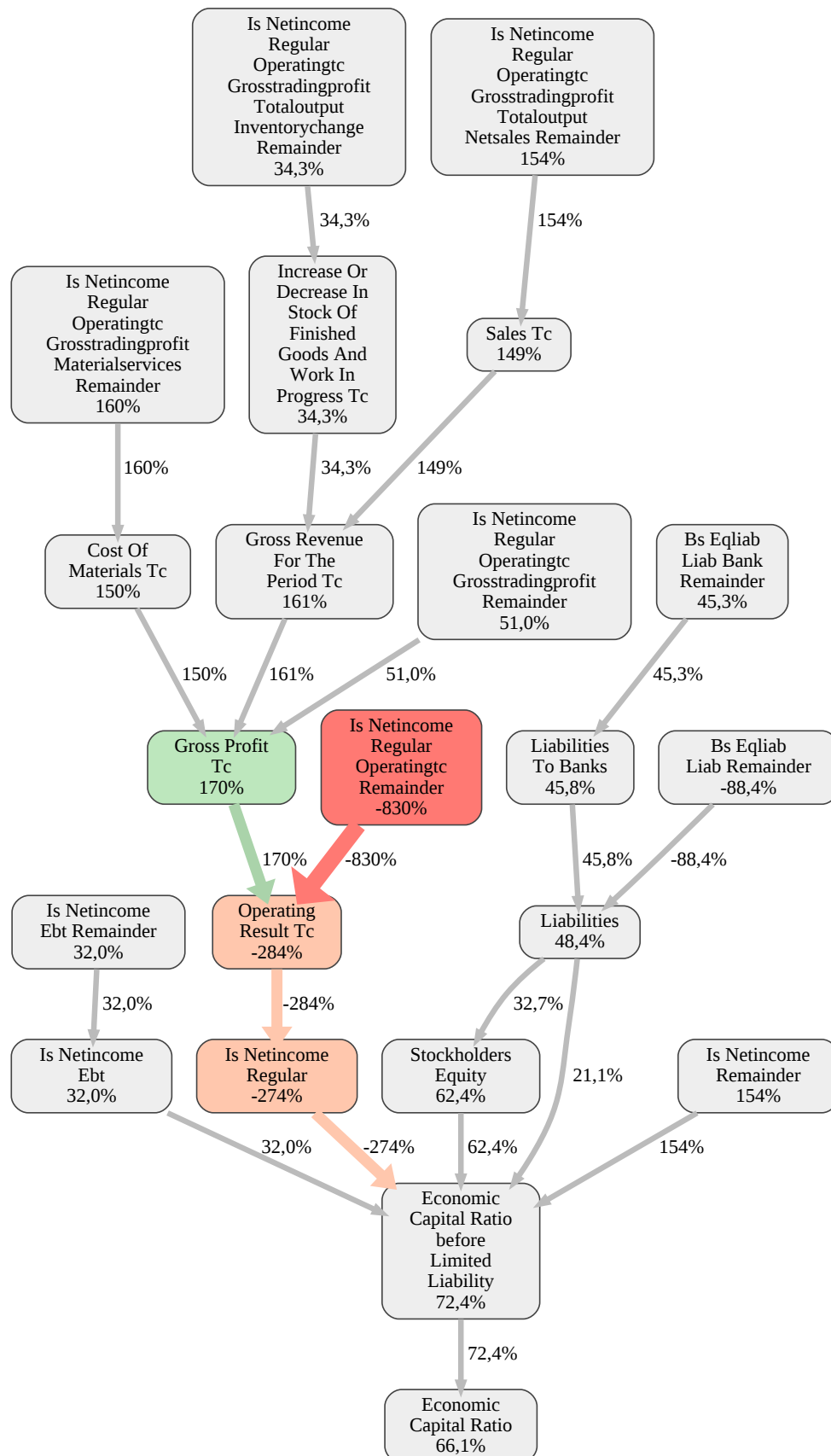




The relative strengths and weaknesses of Ortwin Goldbeck Holding SE Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ortwin Goldbeck Holding SE Konzern compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 170% points. The greatest weakness of Ortwin Goldbeck Holding SE Konzern is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 830% points.

The company's Economic Capital Ratio, given in the ranking table, is 170%, being 66% points above the market average of 104%.
