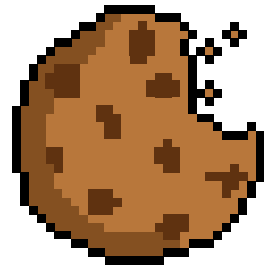
The greatest strength of Gesobau AG Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Gesobau AG Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 264% points.

The company's Economic Capital Ratio, given in the ranking table, is 63%, being 41% points below the market average of 104%.
