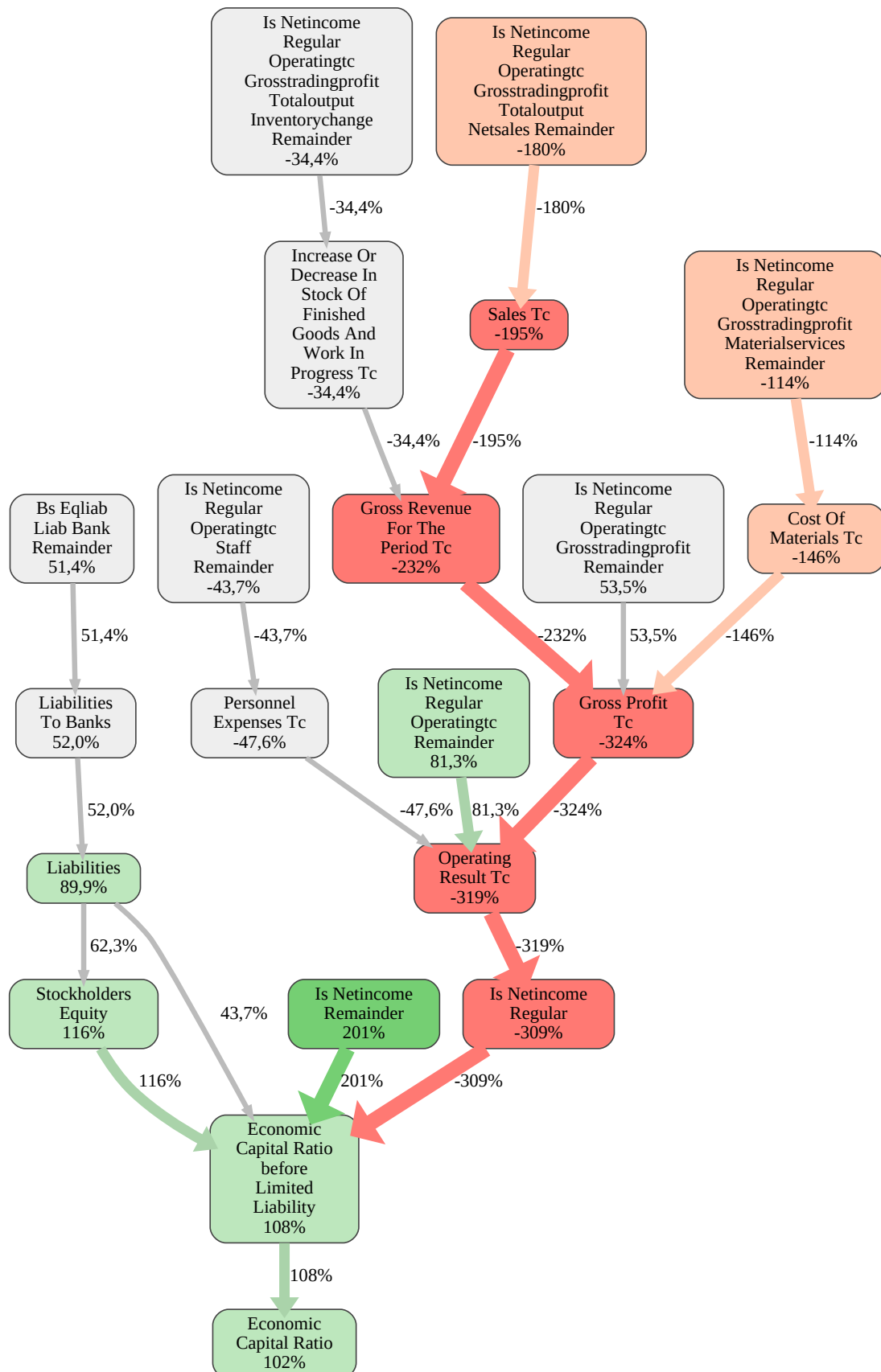




The relative strengths and weaknesses of Koop Bremsendienst GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Koop Bremsendienst GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 201% points. The greatest weakness of Koop Bremsendienst GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 324% points.

The company's Economic Capital Ratio, given in the ranking table, is 205%, being 102% points above the market average of 104%.
