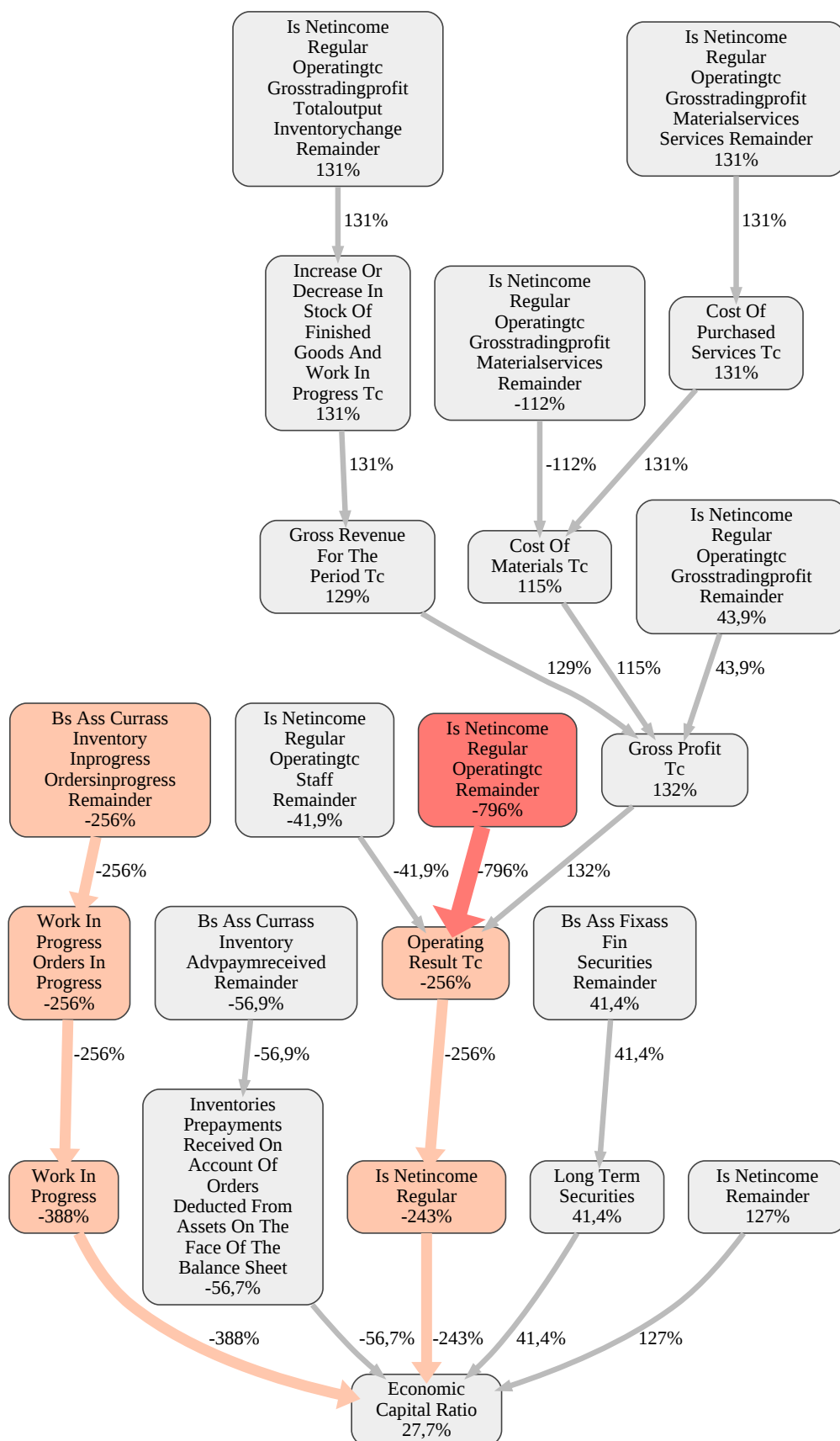




The relative strengths and weaknesses of Schrobsdorff Holding AG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG Konzern compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 132% points. The greatest weakness of Schrobsdorff Holding AG Konzern is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 796% points.

The company's Economic Capital Ratio, given in the ranking table, is 132%, being 28% points above the market average of 104%.
