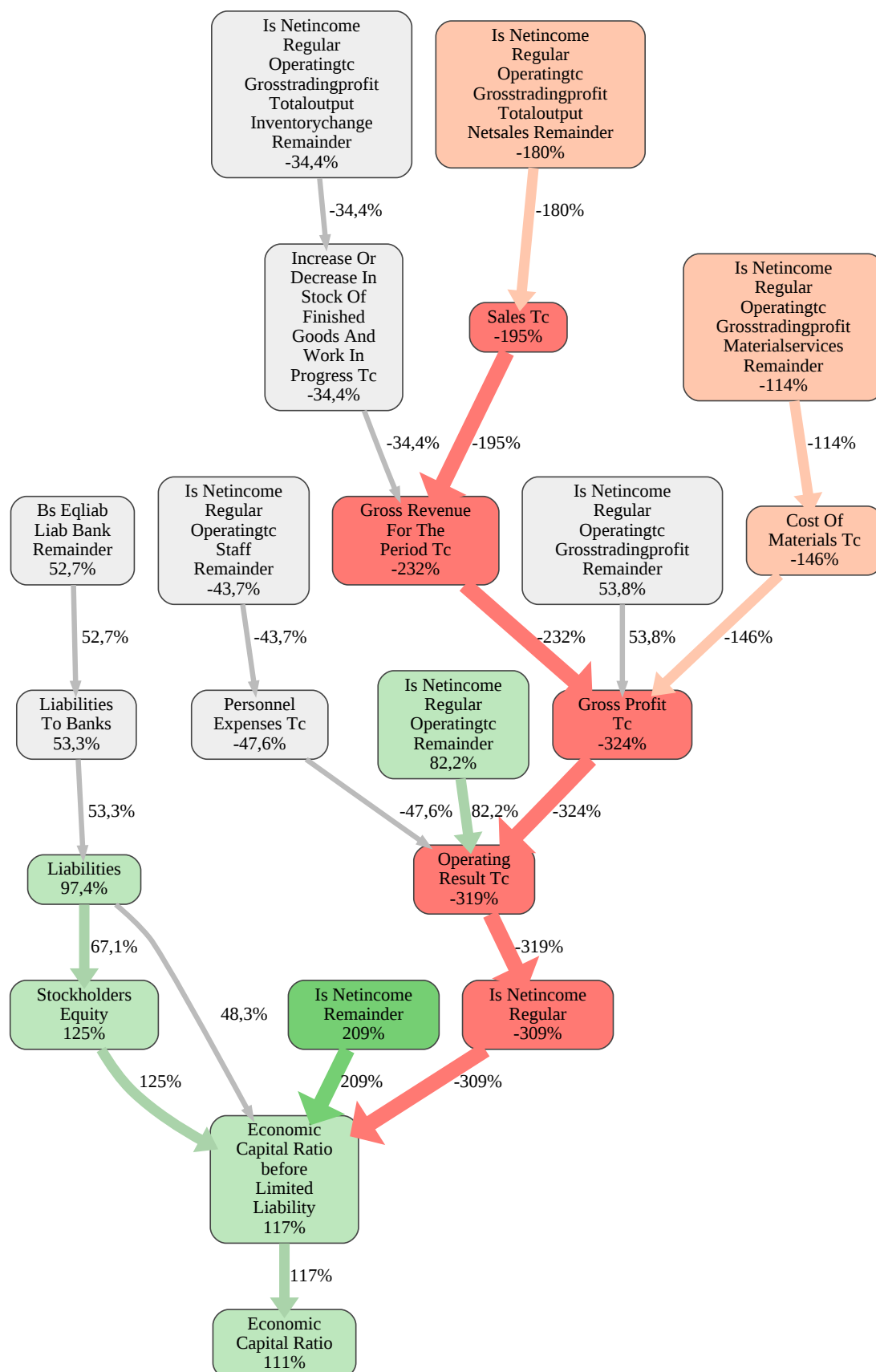




The relative strengths and weaknesses of Fermo Massivhaus Holding Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fermo Massivhaus Holding Aktiengesellschaft compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 209% points. The greatest weakness of Fermo Massivhaus Holding Aktiengesellschaft is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 324% points.

The company's Economic Capital Ratio, given in the ranking table, is 215%, being 111% points above the market average of 104%.
