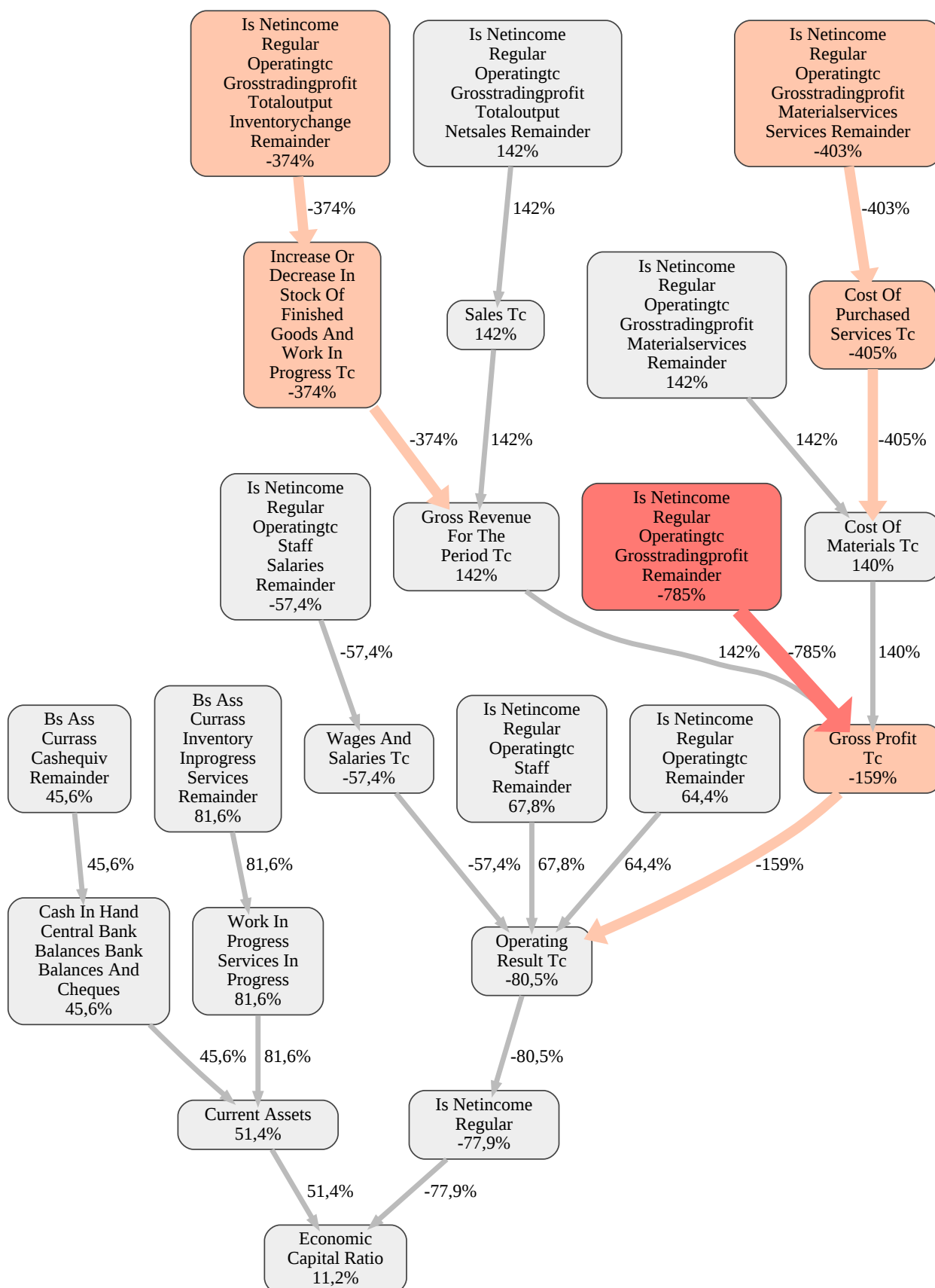




The relative strengths and weaknesses of Nesslerer bau gmbh are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Nesslerer bau gmbh compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 142% points. The greatest weakness of Nesslerer bau gmbh is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 785% points.

The company's Economic Capital Ratio, given in the ranking table, is 142%, being 11% points above the market average of 130%.
