The greatest strength of Wohlfühlhaus Bau GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Wohlfühlhaus Bau GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 294% points.

The company's Economic Capital Ratio, given in the ranking table, is 47%, being 84% points below the market average of 130%.
