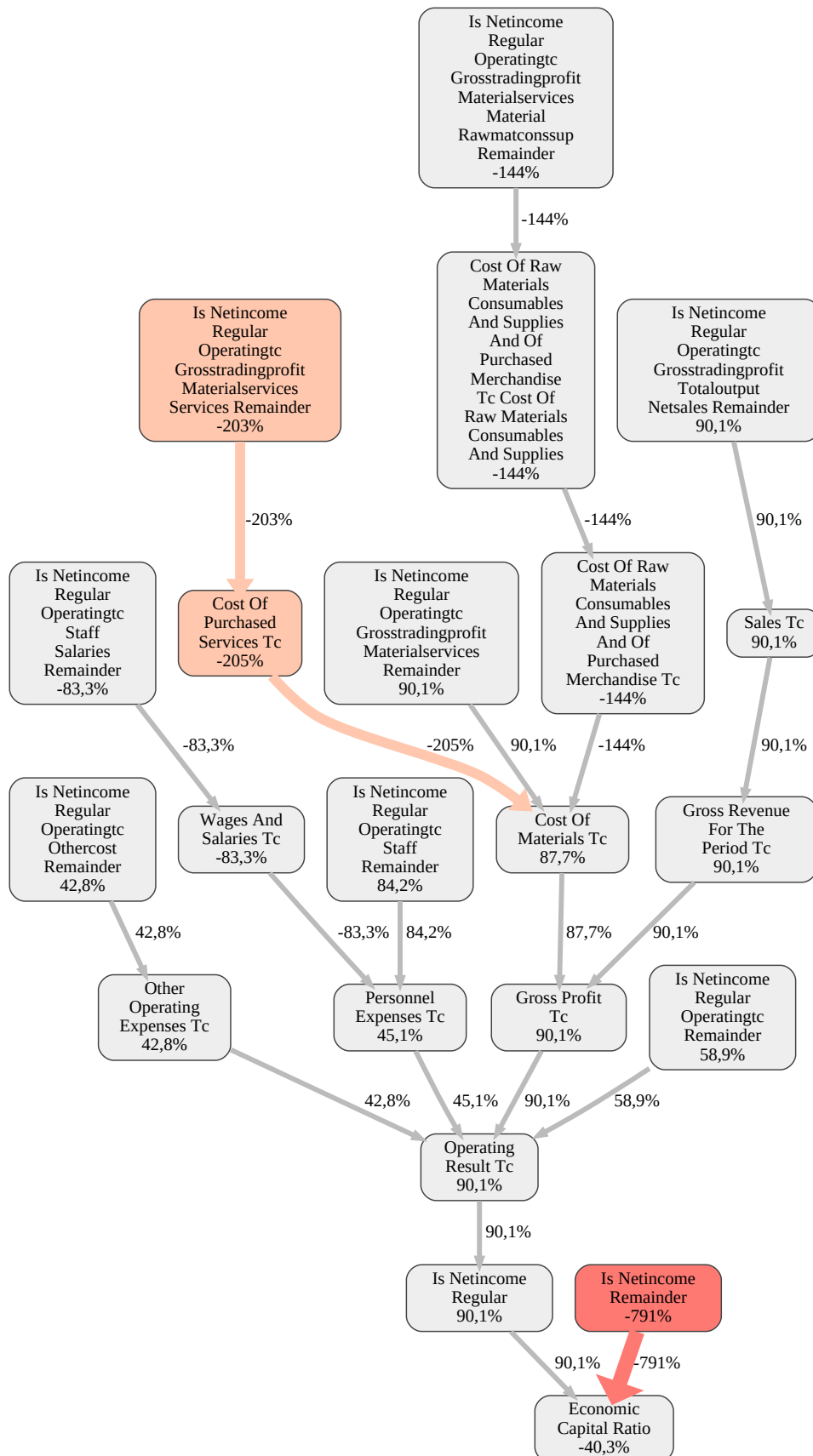




The relative strengths and weaknesses of Haas Fertigbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Haas Fertigbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 90% points. The greatest weakness of Haas Fertigbau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 791% points.

The company's Economic Capital Ratio, given in the ranking table, is 90%, being 40% points below the market average of 130%.
