



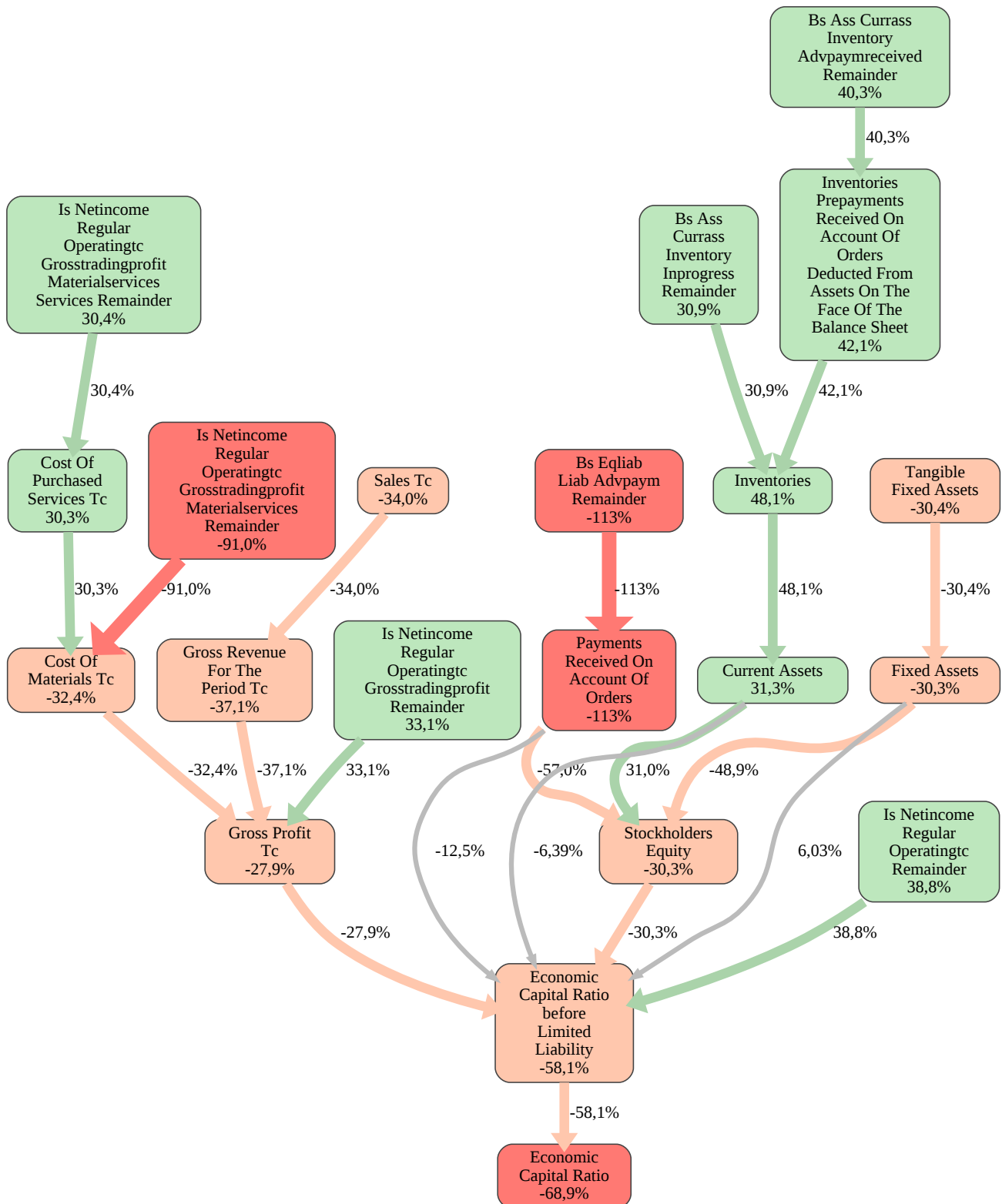

The relative strengths and weaknesses of Lim Hoch und Tiefbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lim Hoch und Tiefbau GmbH compared to the market average is the variable Inventories, increasing the Economic Capital Ratio by 48% points. The greatest weakness of Lim Hoch und Tiefbau GmbH is the variable Bs Eqliab Liab Advpaym Remainder, reducing the Economic Capital Ratio by 113% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 69% points below the market average of 130%.
