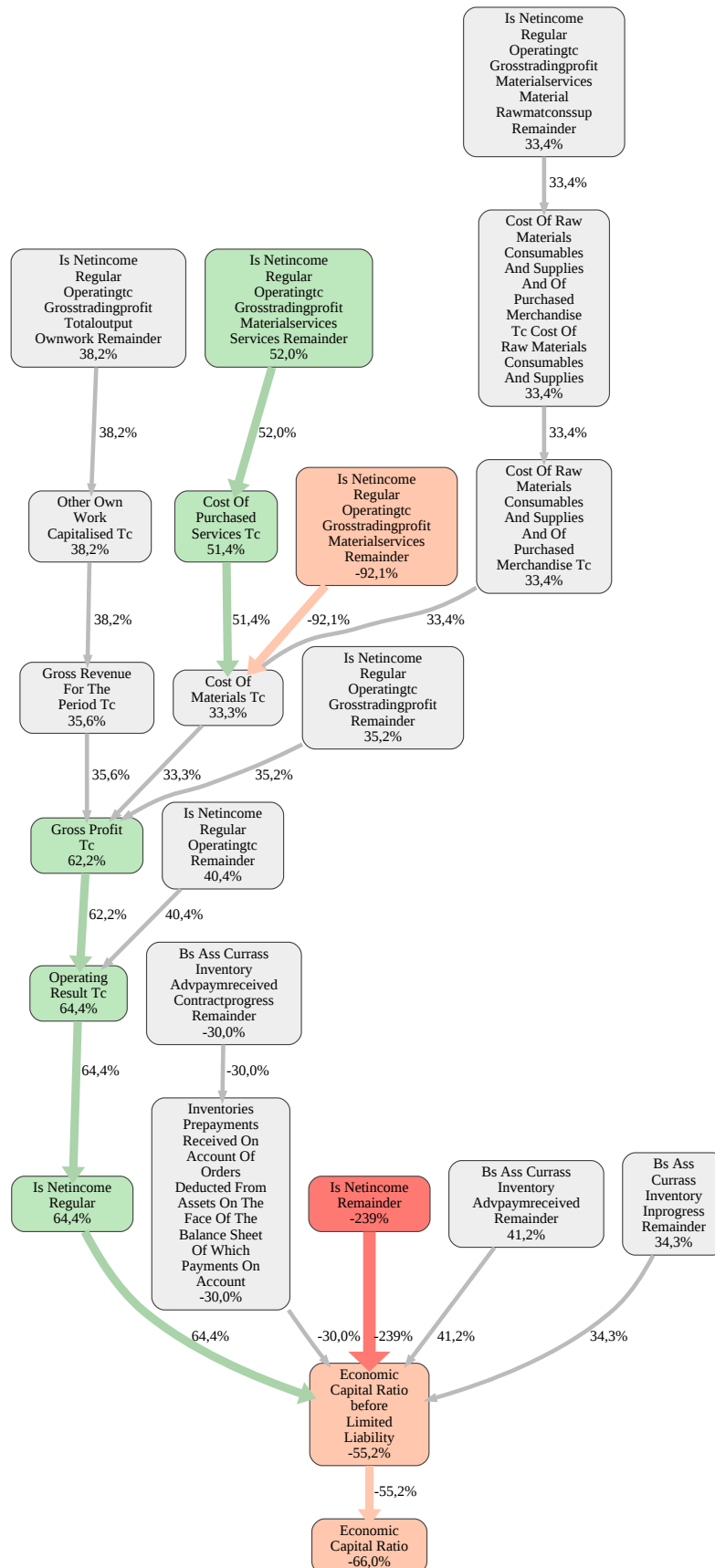




The relative strengths and weaknesses of Jökel Bau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Jökel Bau GmbH Co KG compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 64% points. The greatest weakness of Jökel Bau GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 239% points.

The company's Economic Capital Ratio, given in the ranking table, is 64%, being 66% points below the market average of 130%.
