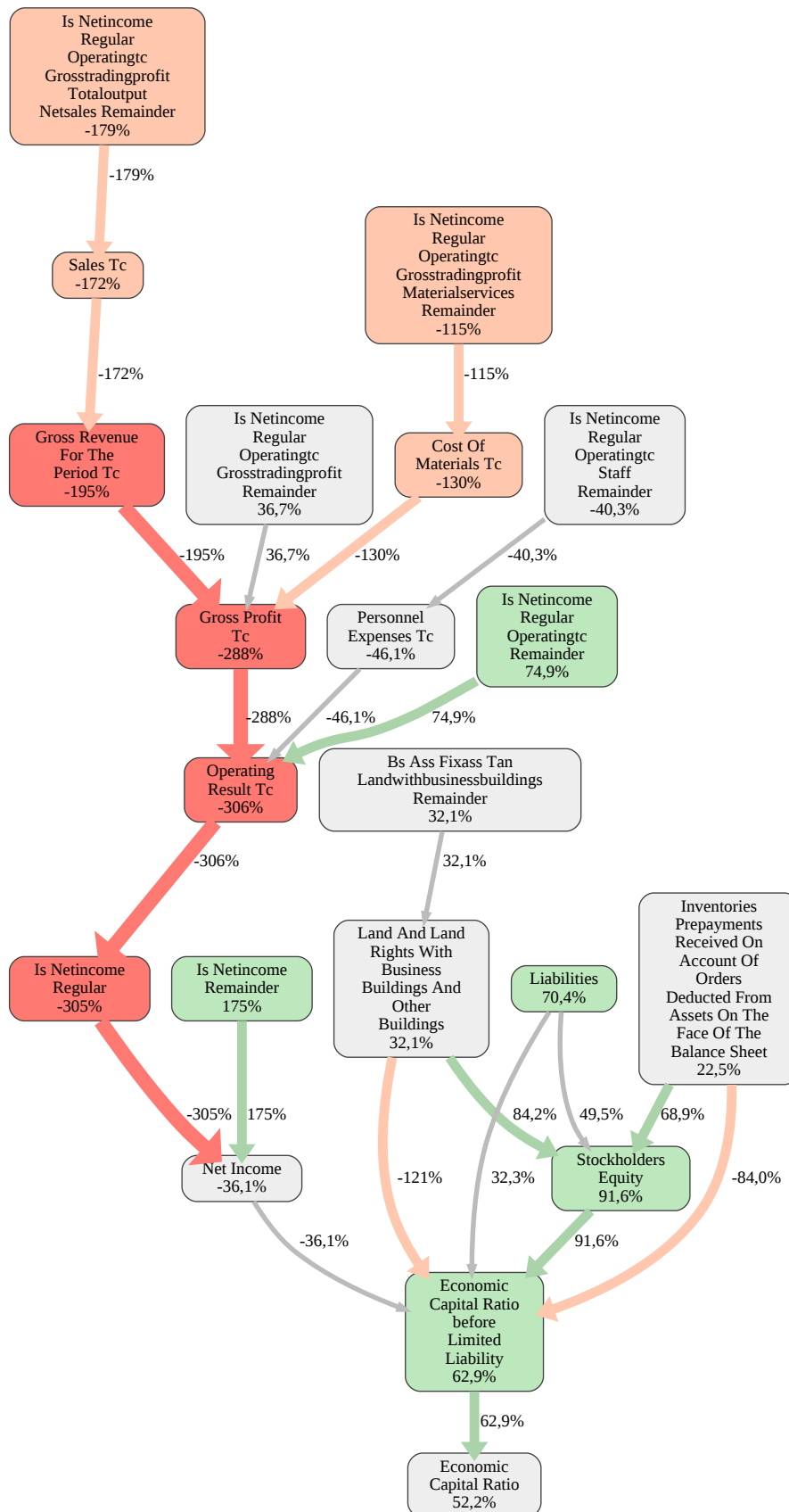




The relative strengths and weaknesses of Freie Scholle Bau und Dienstleistungs GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Freie Scholle Bau und Dienstleistungs GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 175% points. The greatest weakness of Freie Scholle Bau und Dienstleistungs GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 306% points.

The company's Economic Capital Ratio, given in the ranking table, is 183%, being 52% points above the market average of 130%.
