



The relative strengths and weaknesses of Wohnungsbaugesellschaft Lichtenberg mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Lichtenberg mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 84% points. The greatest weakness of Wohnungsbaugesellschaft Lichtenberg mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 262% points.

The company's Economic Capital Ratio, given in the ranking table, is 84%, being 47% points below the market average of 130%.
