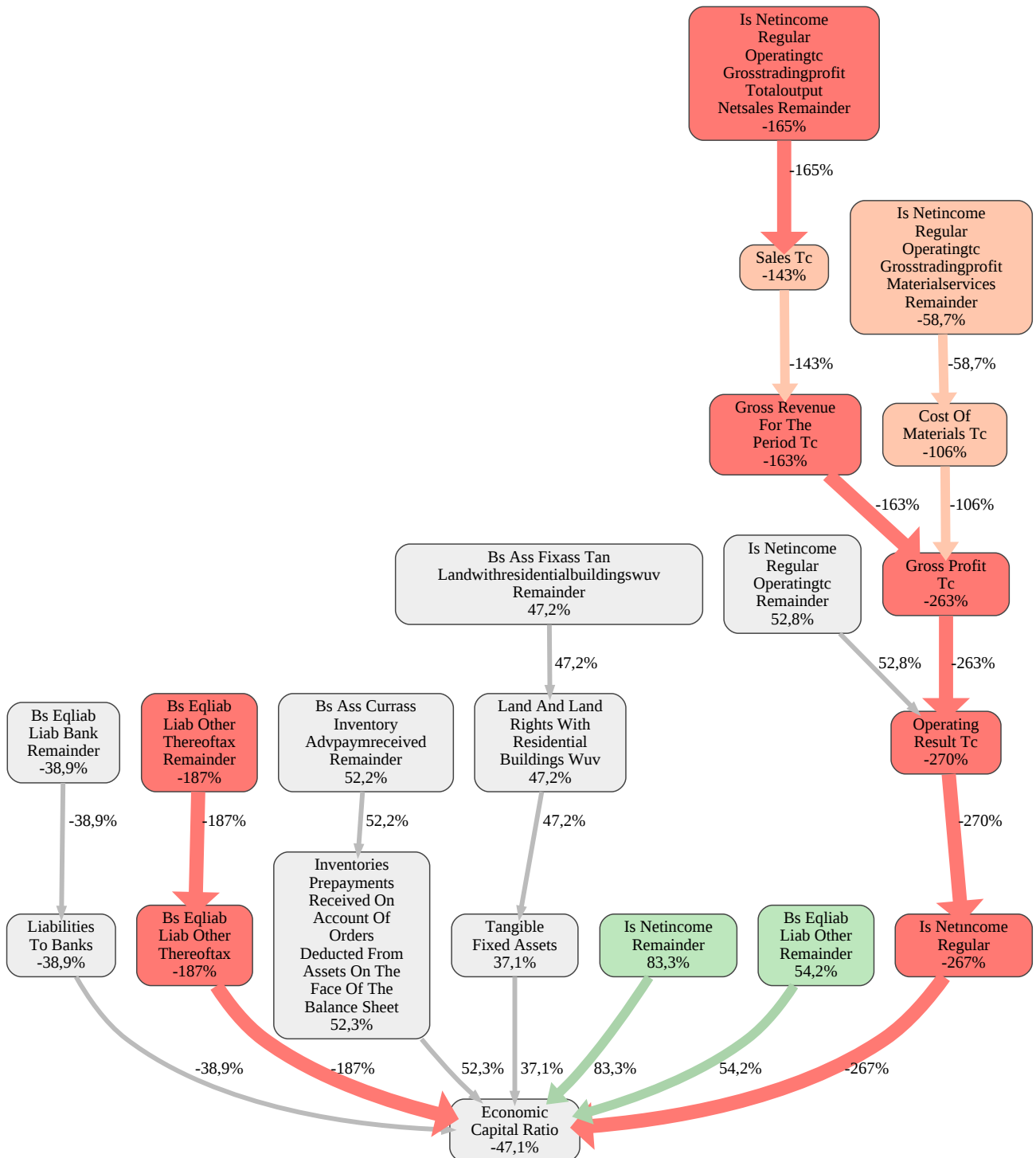




The relative strengths and weaknesses of Sewoba GmbH Seelower Wohnungsbaugesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Sewoba GmbH Seelower Wohnungsbaugesellschaft compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Sewoba GmbH Seelower Wohnungsbaugesellschaft is the variable Operating Result Tc, reducing the Economic Capital Ratio by 270% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 47% points below the market average of 130%.
