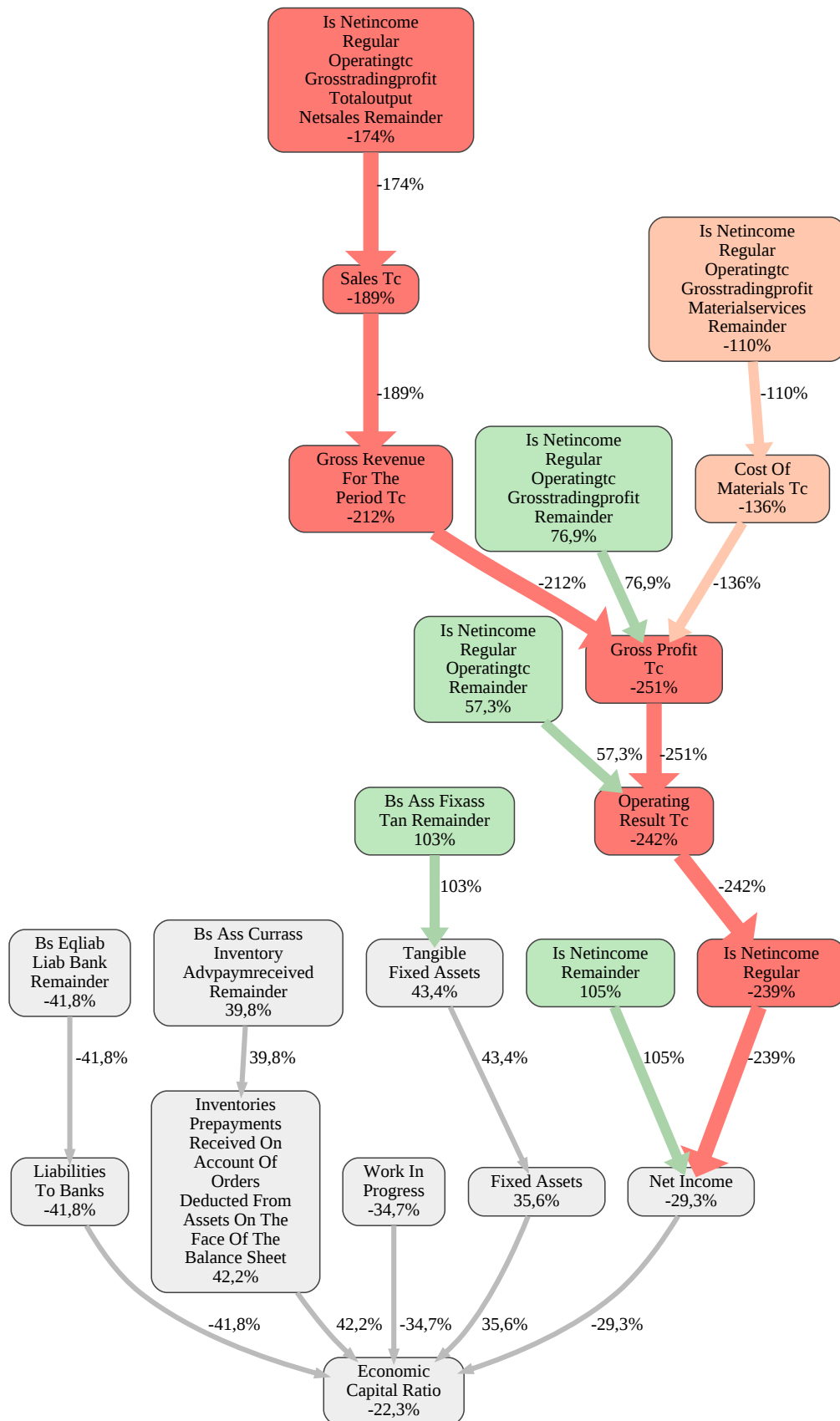




The relative strengths and weaknesses of Wohnungsbaugesellschaft mbH Malchow are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft mbH Malchow compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 105% points. The greatest weakness of Wohnungsbaugesellschaft mbH Malchow is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 251% points.

The company's Economic Capital Ratio, given in the ranking table, is 108%, being 22% points below the market average of 130%.
