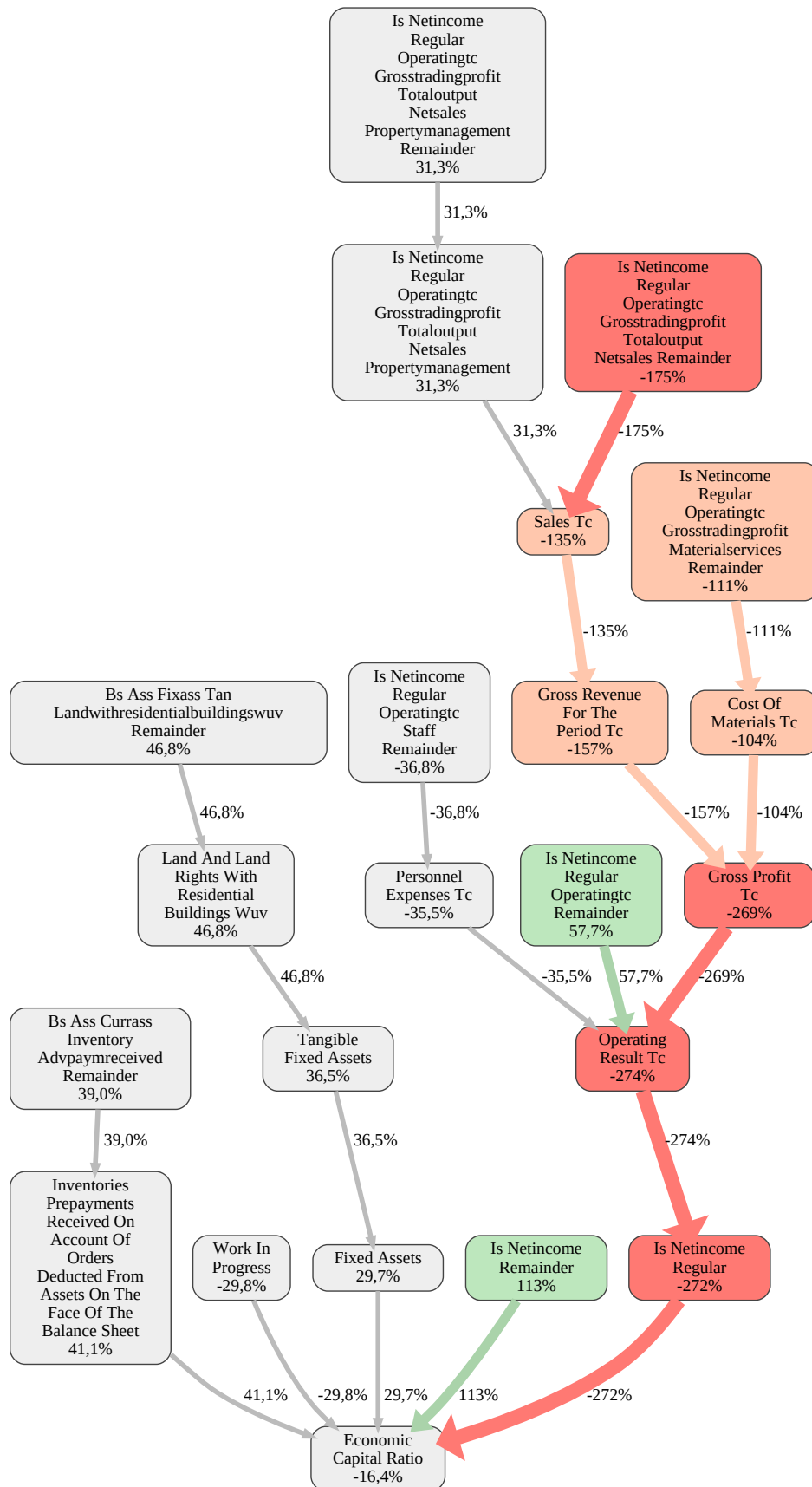




The relative strengths and weaknesses of Kyritzer Wohnungsbaugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kyritzer Wohnungsbaugesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 113% points. The greatest weakness of Kyritzer Wohnungsbaugesellschaft mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 274% points.

The company's Economic Capital Ratio, given in the ranking table, is 114%, being 16% points below the market average of 130%.
