The greatest strength of Wohnungsbaugesellschaft mbH der Hansestadt Wismar compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Wohnungsbaugesellschaft mbH der Hansestadt Wismar is the variable Operating Result Tc, reducing the Economic Capital Ratio by 235% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 51% points below the market average of 130%.
