



The relative strengths and weaknesses of Bonava Wohnbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bonava Wohnbau GmbH compared to the market average is the variable Is Netincome Regular Operatingcogs Grossoprofit Remainder, increasing the Economic Capital Ratio by 33% points. The greatest weakness of Bonava Wohnbau GmbH is the variable Is Netincome Regular Operatingcogs Grossoprofit Cogs Remainder, reducing the Economic Capital Ratio by 125% points.

The company's Economic Capital Ratio, given in the ranking table, is 33%, being 97% points below the market average of 130%.
