The relative strengths and weaknesses of HIW Hoch und Ingenieurbau Wilsdruff GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HIW Hoch und Ingenieurbau Wilsdruff GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 111% points. The greatest weakness of HIW Hoch und Ingenieurbau Wilsdruff GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 369% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 19% points below the market average of 130%.
