

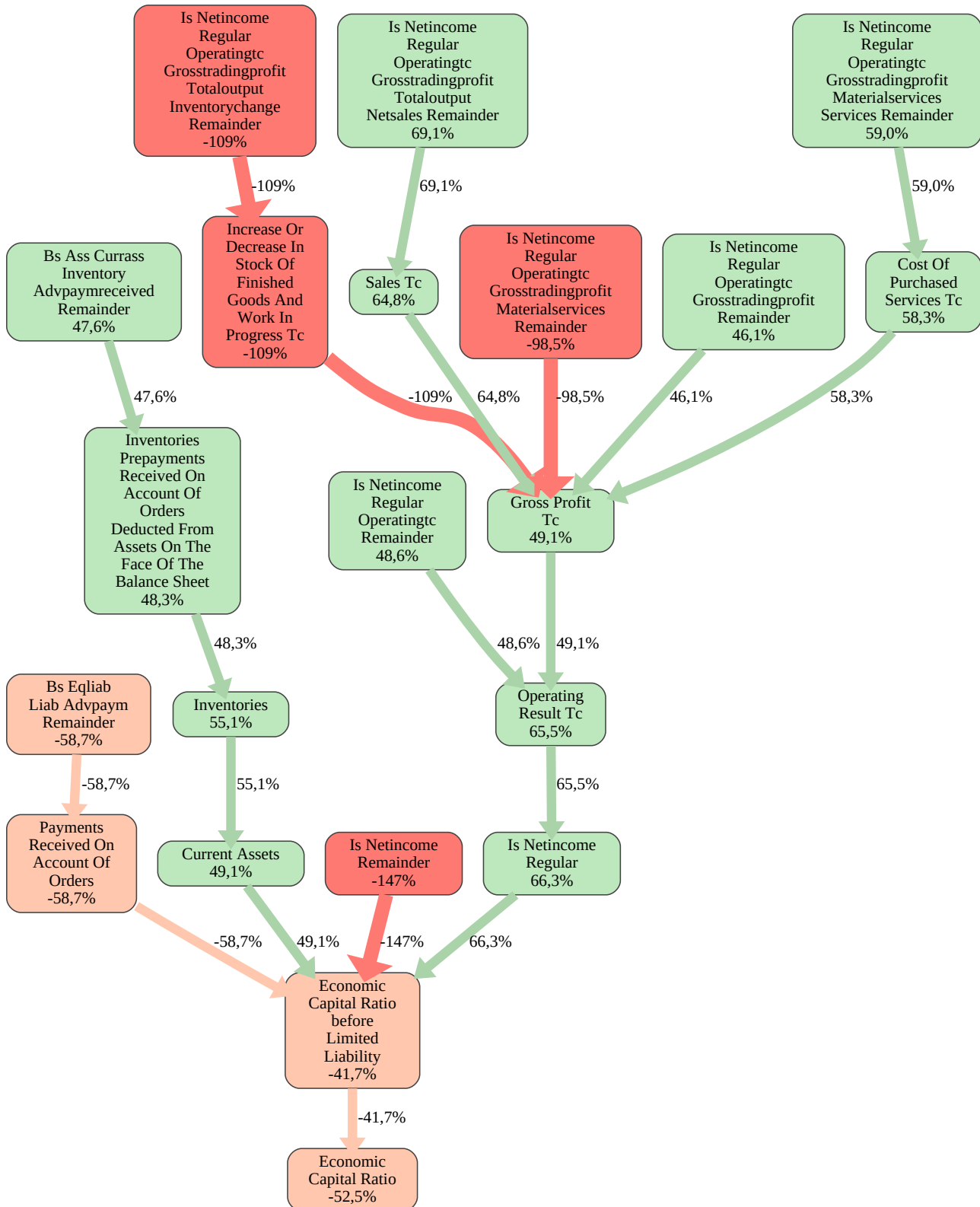

The relative strengths and weaknesses of OBAG Hochbau Gesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of OBAG Hochbau Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 69% points. The greatest weakness of OBAG Hochbau Gesellschaft mit Beschränkter Haftung is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 147% points.

The company's Economic Capital Ratio, given in the ranking table, is 78%, being 52% points below the market average of 130%.
