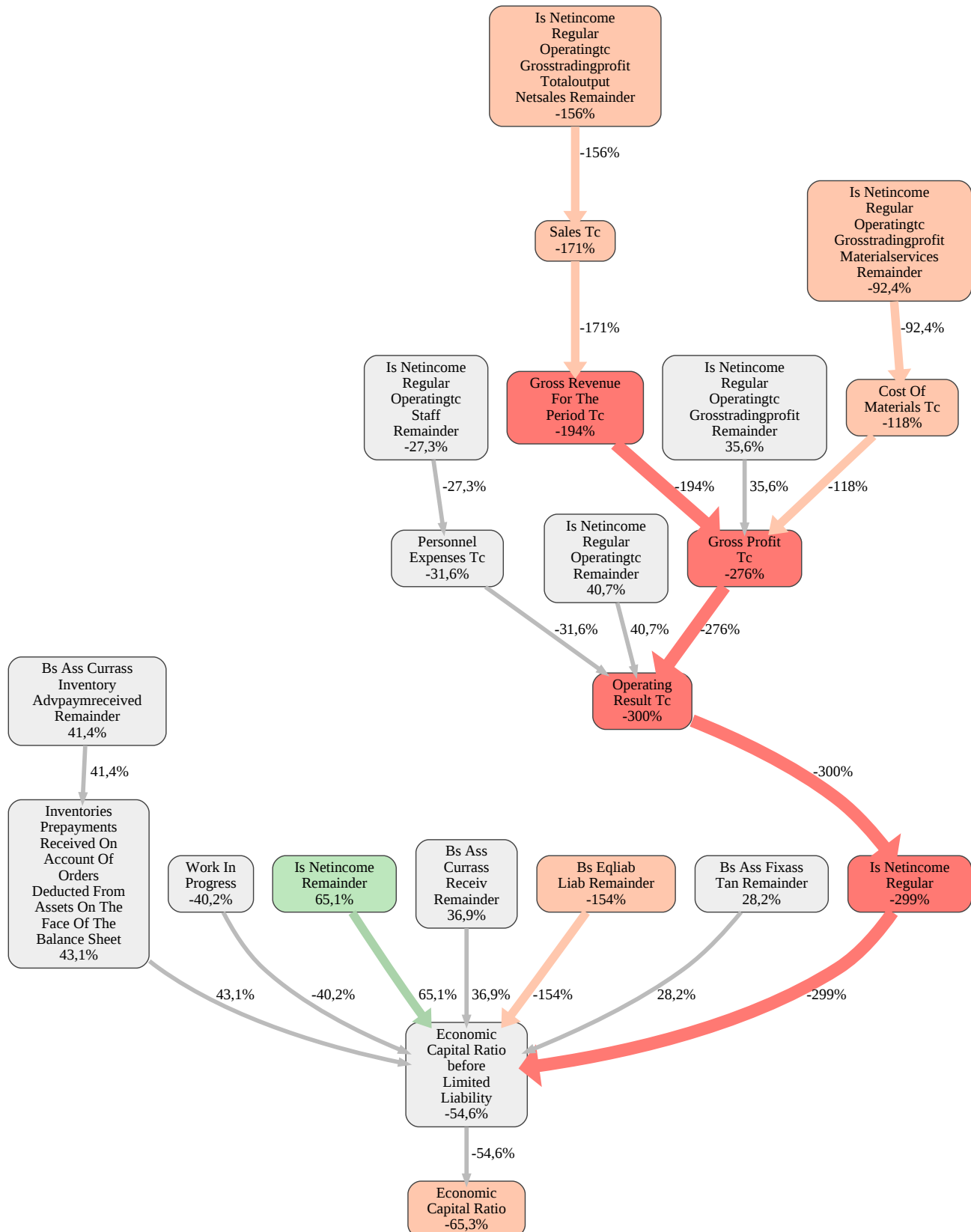




The relative strengths and weaknesses of HS Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HS Bau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 65% points. The greatest weakness of HS Bau GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 300% points.

The company's Economic Capital Ratio, given in the ranking table, is 65%, being 65% points below the market average of 130%.
