



The relative strengths and weaknesses of Hubert Schmid Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hubert Schmid Bauunternehmen GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 87% points. The greatest weakness of Hubert Schmid Bauunternehmen GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 185% points.

The company's Economic Capital Ratio, given in the ranking table, is 100%, being 30% points below the market average of 130%.
