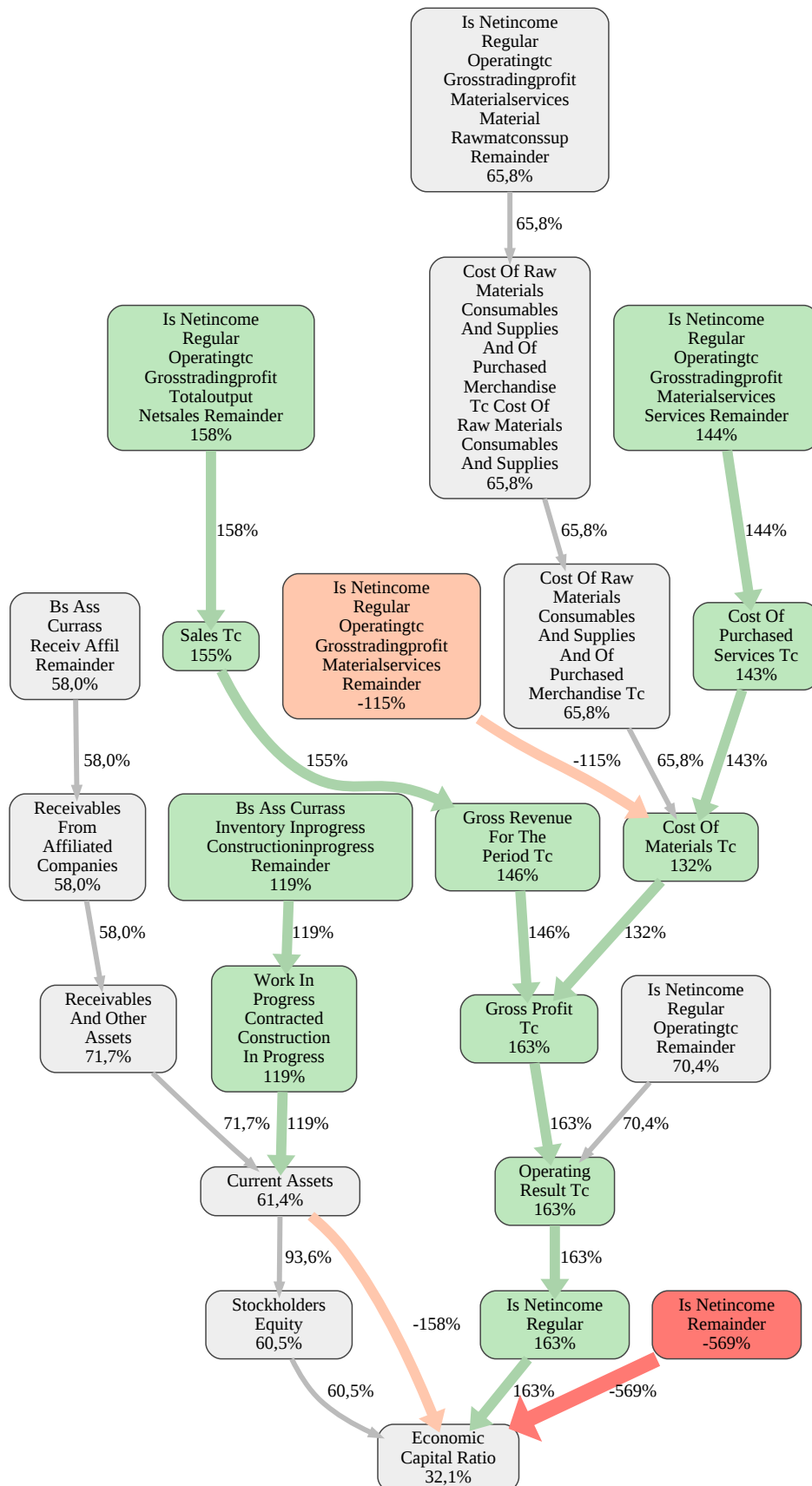




The relative strengths and weaknesses of Josef Rädlinger Ingenieurbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Rädlinger Ingenieurbau GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 163% points. The greatest weakness of Josef Rädlinger Ingenieurbau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 569% points.

The company's Economic Capital Ratio, given in the ranking table, is 163%, being 32% points above the market average of 130%.
