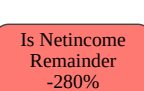




Eiffage Infra Bau SE Konzern

The relative strengths and weaknesses of Eiffage Infra Bau SE Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Eiffage Infra Bau SE Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Services Remainder, increasing the Economic Capital Ratio by 66% points. The greatest weakness of Eiffage Infra Bau SE Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 280% points.

The company's Economic Capital Ratio, given in the ranking table, is 66%, being 65% points below the market average of 130%.
