



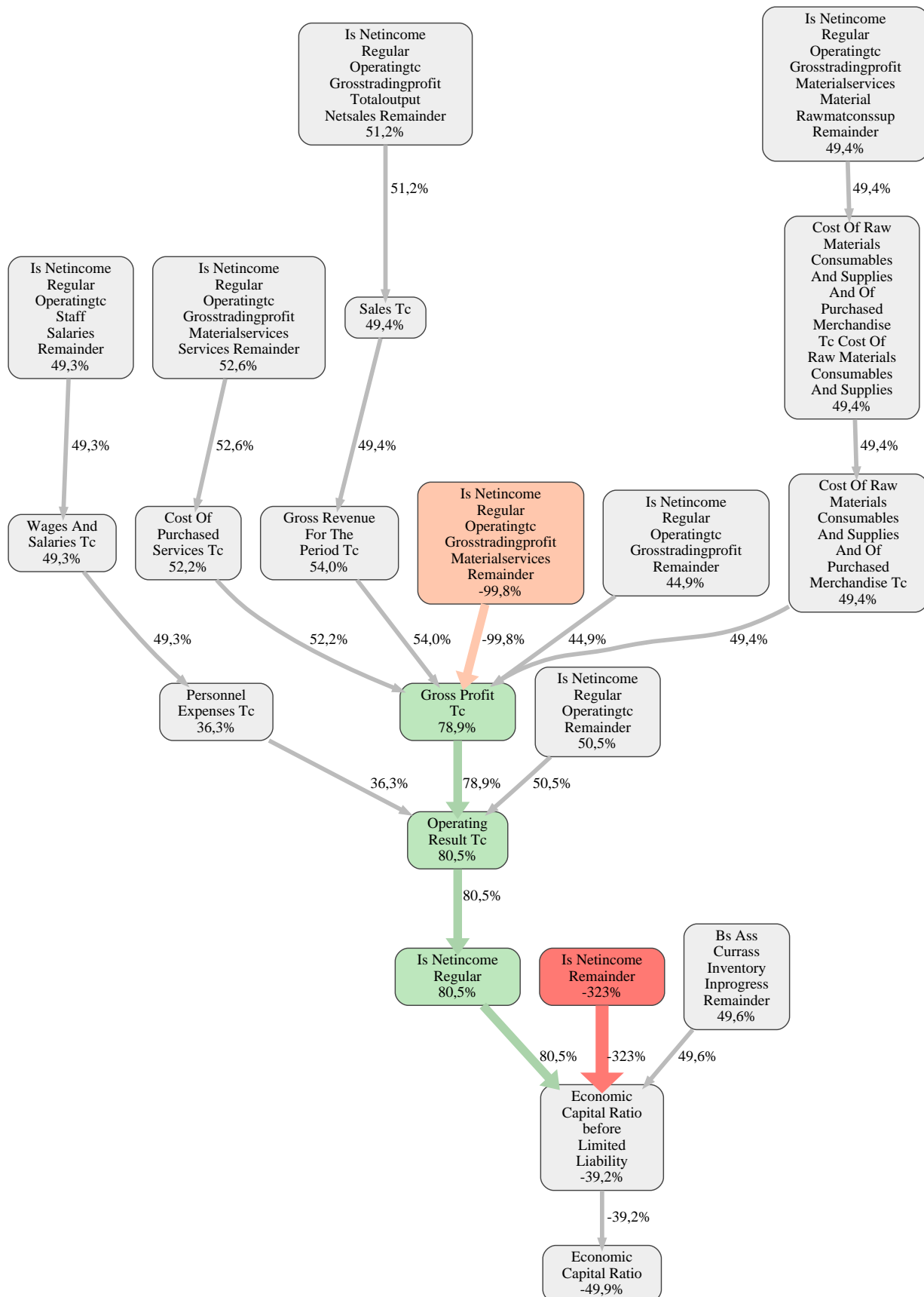

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 81% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 323% points.

The company's Economic Capital Ratio, given in the ranking table, is 81%, being 50% points below the market average of 130%.
