The greatest strength of Bauunternehmung Hermann GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 108% points. The greatest weakness of Bauunternehmung Hermann GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 706% points.

The company's Economic Capital Ratio, given in the ranking table, is 108%, being 6,8% points above the market average of 102%.
