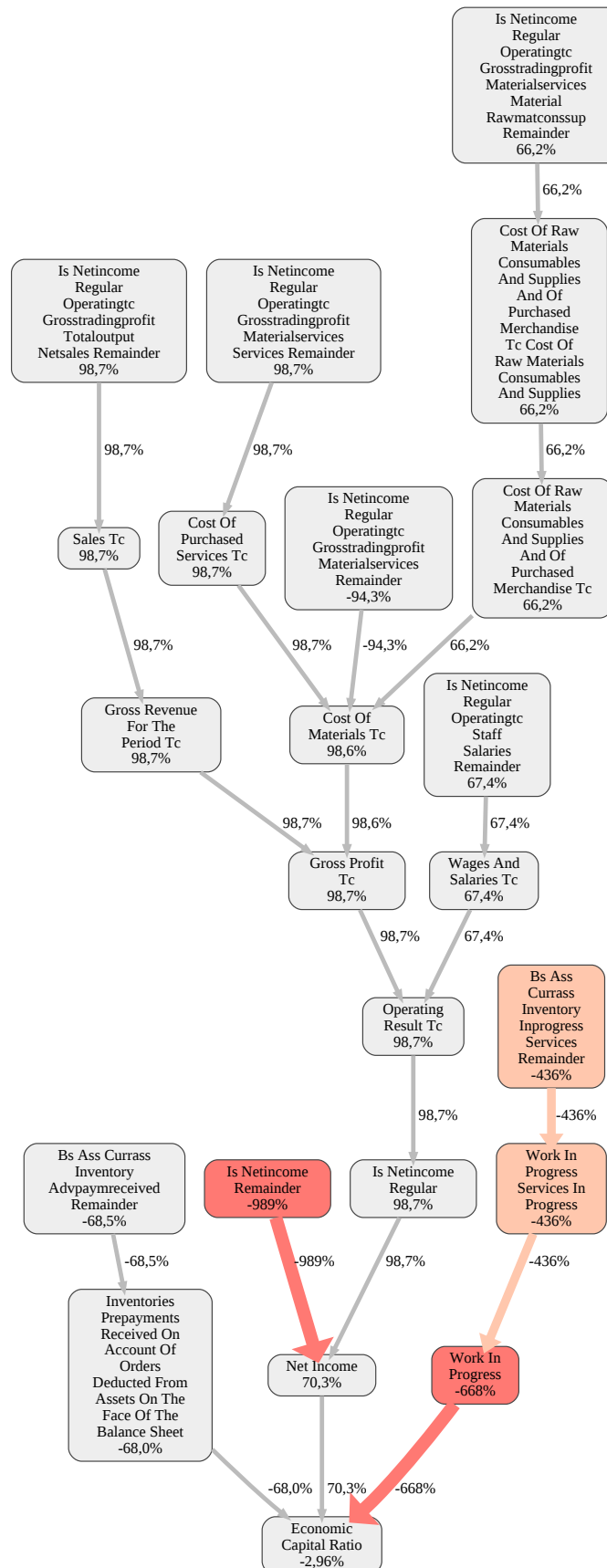

The greatest strength of Bauunternehmung Hofschröder GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Bauunternehmung Hofschröder GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 989% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 3,0% points below the market average of 102%.
