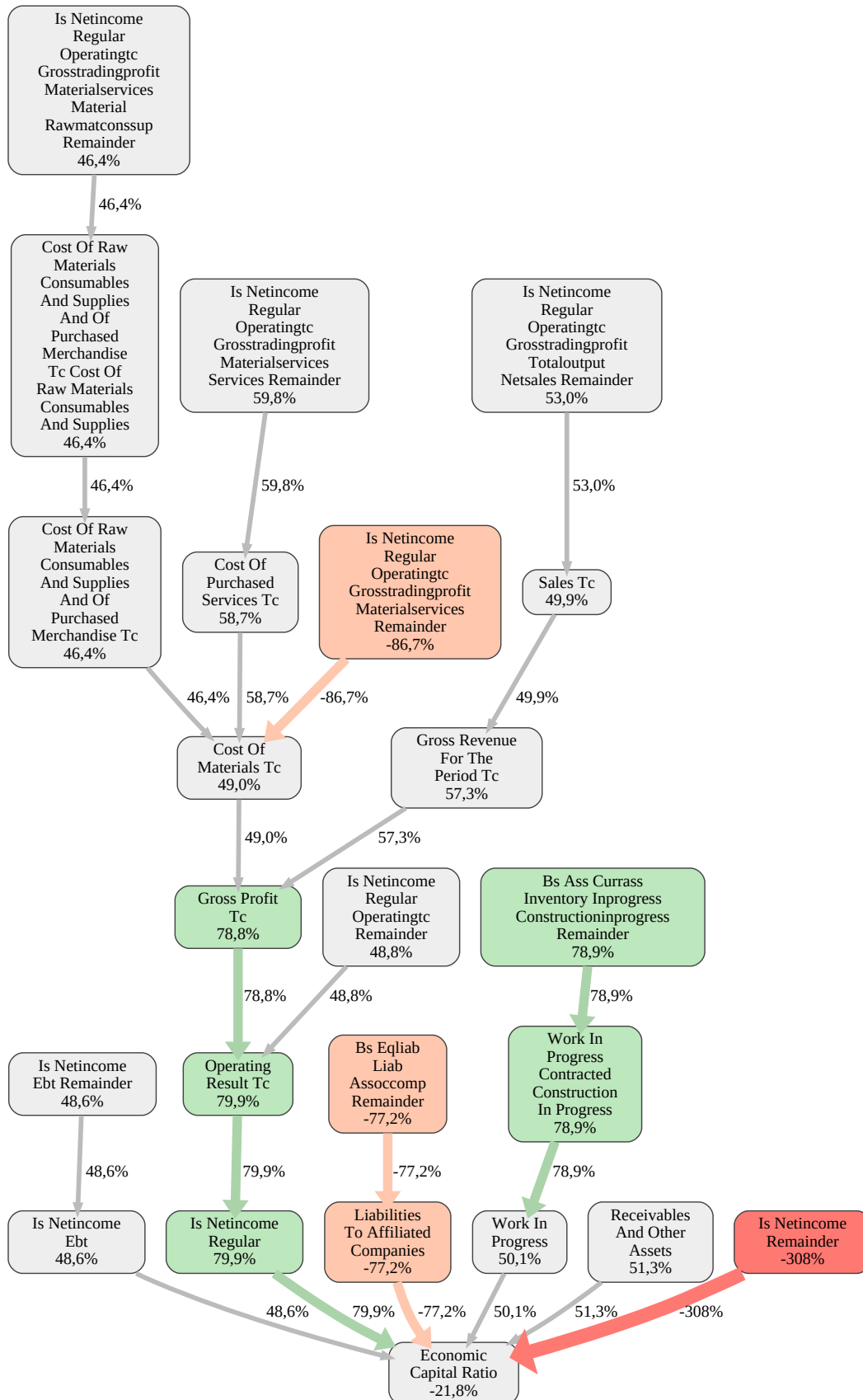




The relative strengths and weaknesses of Josef Rädlinger Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Rädlinger Bauunternehmen GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Josef Rädlinger Bauunternehmen GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 308% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 22% points below the market average of 102%.
