The greatest strength of Josef Fuchs Bauunternehmen GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Josef Fuchs Bauunternehmen GmbH Co KG is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 165% points.

The company's Economic Capital Ratio, given in the ranking table, is 53%, being 49% points below the market average of 102%.
