The greatest strength of Finsterwalder Bau Union GmbH Sitz Zeckerin compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Finsterwalder Bau Union GmbH Sitz Zeckerin is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 319% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 11% points below the market average of 102%.
