



The relative strengths and weaknesses of Moser GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Moser GmbH Co KG compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 133% points. The greatest weakness of Moser GmbH Co KG is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 1.031% points.

The company's Economic Capital Ratio, given in the ranking table, is 133%, being 31% points above the market average of 102%.
