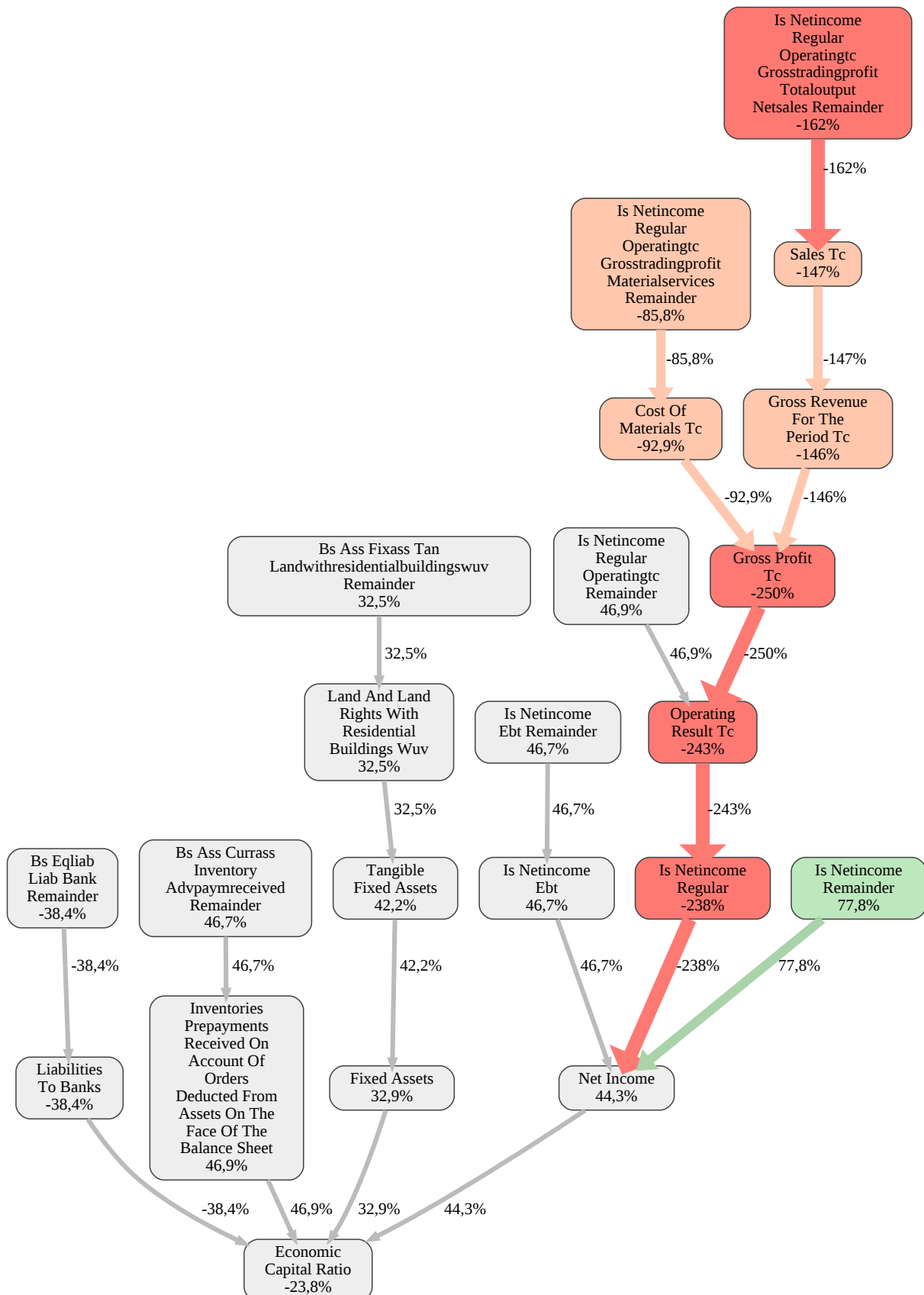




The relative strengths and weaknesses of Wohnungsbaugesellschaft Alsdorf mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Alsdorf mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 78% points. The greatest weakness of Wohnungsbaugesellschaft Alsdorf mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 250% points.

The company's Economic Capital Ratio, given in the ranking table, is 78%, being 24% points below the market average of 102%.
