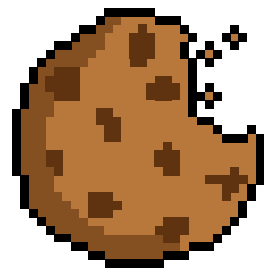
The greatest strength of Gesobau AG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 60% points. The greatest weakness of Gesobau AG is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 226% points.

The company's Economic Capital Ratio, given in the ranking table, is 60%, being 41% points below the market average of 102%.

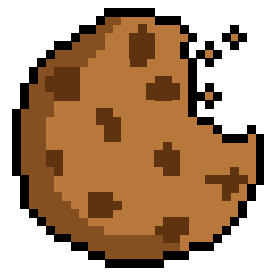
