



The relative strengths and weaknesses of Degewo Köpenicker Wohnungsgesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Degewo Köpenicker Wohnungsgesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 57% points. The greatest weakness of Degewo Köpenicker Wohnungsgesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 218% points.

The company's Economic Capital Ratio, given in the ranking table, is 57%, being 45% points below the market average of 102%.
