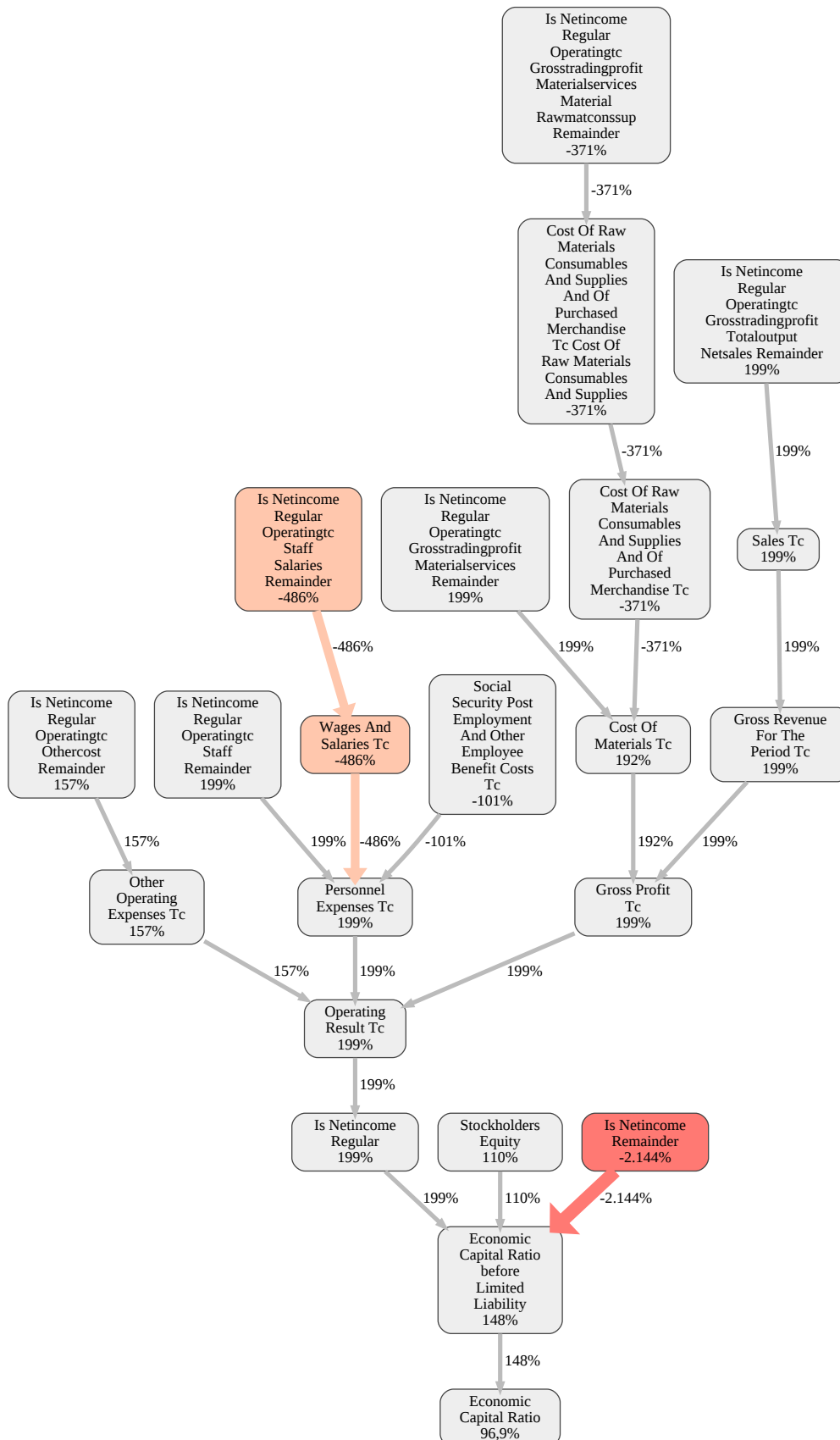




The relative strengths and weaknesses of Degewo Technische Dienste GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Degewo Technische Dienste GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 199% points. The greatest weakness of Degewo Technische Dienste GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 2.144% points.

The company's Economic Capital Ratio, given in the ranking table, is 199%, being 97% points above the market average of 102%.
