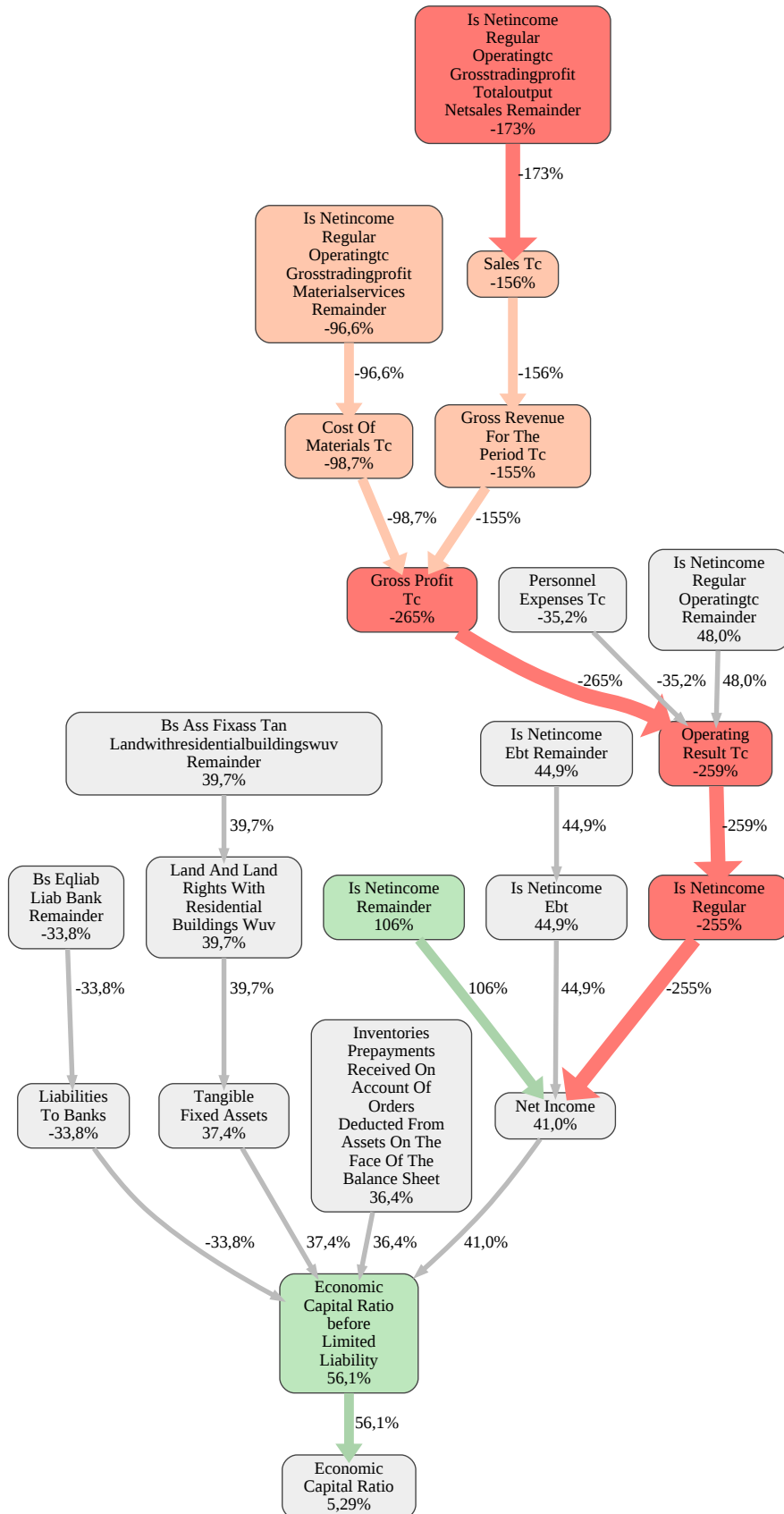




The relative strengths and weaknesses of Wohnungs und Baugesellschaft mbH Bernau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungs und Baugesellschaft mbH Bernau compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 106% points. The greatest weakness of Wohnungs und Baugesellschaft mbH Bernau is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 265% points.

The company's Economic Capital Ratio, given in the ranking table, is 107%, being 5,3% points above the market average of 102%.
