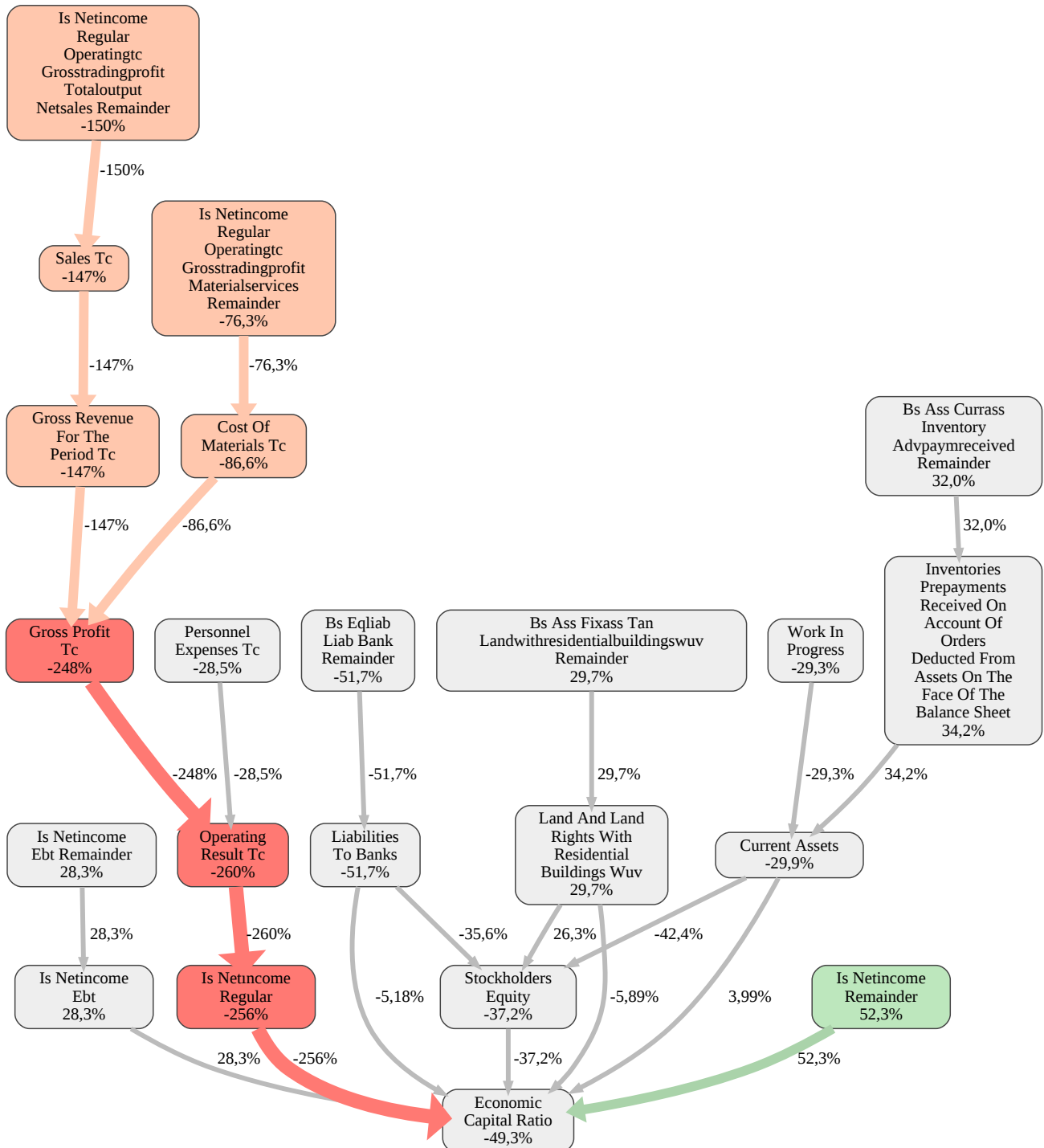




The relative strengths and weaknesses of Wohnungsgesellschaft Recklinghausen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsgesellschaft Recklinghausen mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Wohnungsgesellschaft Recklinghausen mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 260% points.

The company's Economic Capital Ratio, given in the ranking table, is 52%, being 49% points below the market average of 102%.
