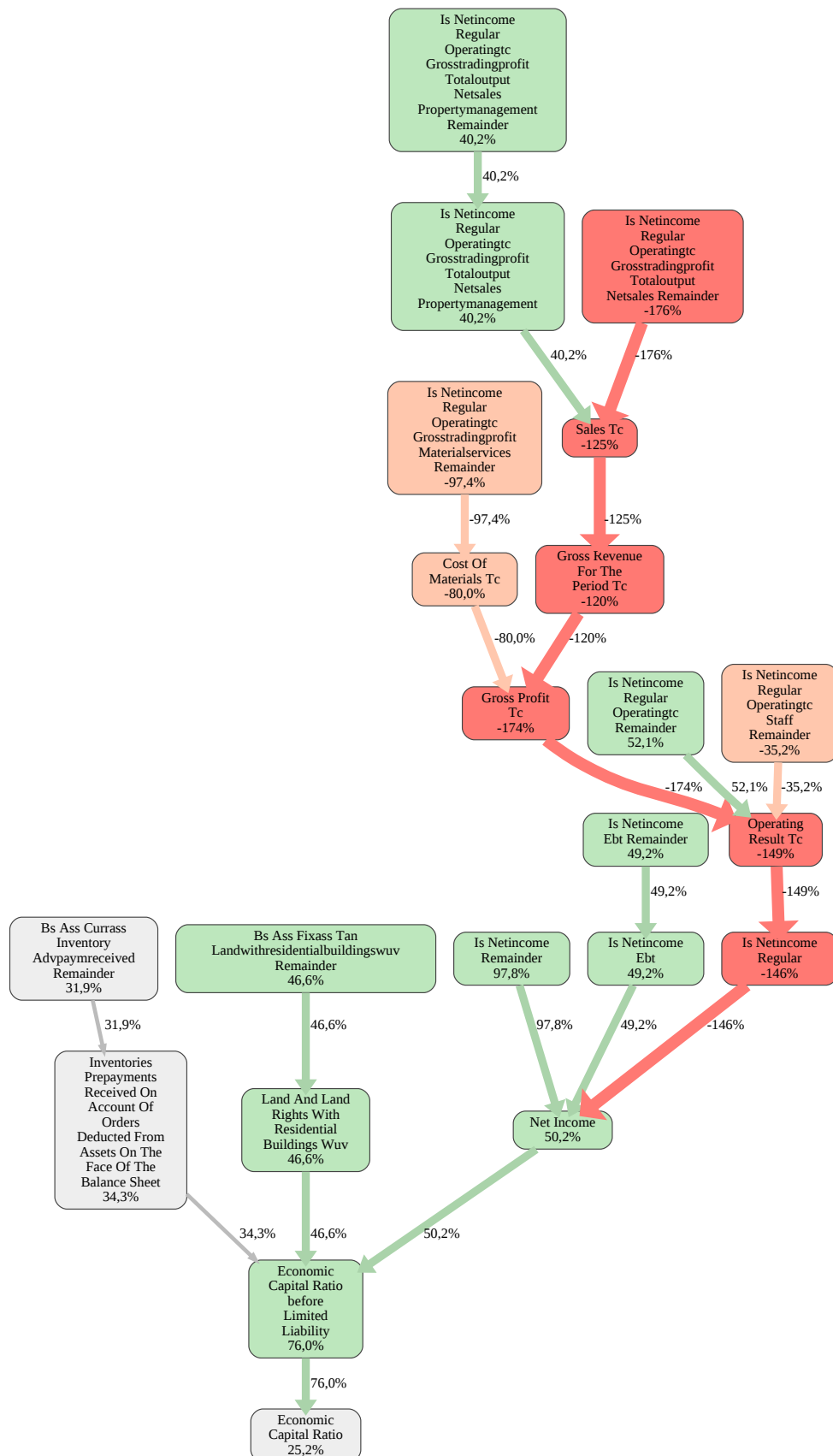




Wohnungsbau und Wohnungsverwaltungsgesellschaft mbH Neustadt Glewe Rank 78 of 325

The relative strengths and weaknesses of Wohnungsbau und Wohnungsverwaltungsgesellschaft mbH Neustadt Glewe are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Wohnungsverwaltungsgesellschaft mbH Neustadt Glewe compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 98% points. The greatest weakness of Wohnungsbau und Wohnungsverwaltungsgesellschaft mbH Neustadt Glewe is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, reducing the Economic Capital Ratio by 176% points.

The company's Economic Capital Ratio, given in the ranking table, is 127%, being 25% points above the market average of 102%.
