





The greatest strength of Stralsunder Wohnungsbaugesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 81% points. The greatest weakness of Stralsunder Wohnungsbaugesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 249% points.

The company's Economic Capital Ratio, given in the ranking table, is 81%, being 21% points below the market average of 102%.
