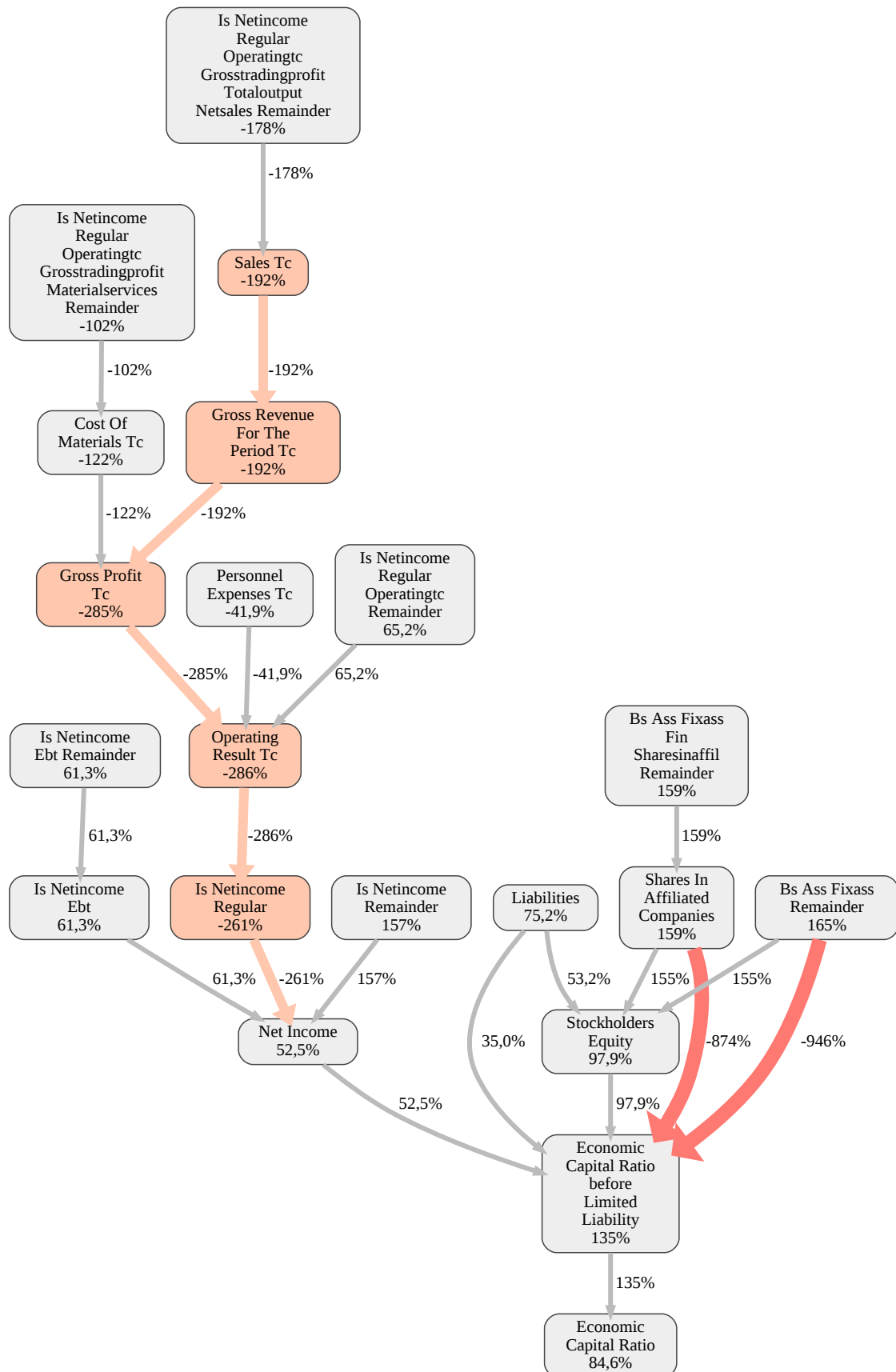




The relative strengths and weaknesses of GWH Immobilien Holding GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GWH Immobilien Holding GmbH compared to the market average is the variable Bs Ass Fixass Remainder, increasing the Economic Capital Ratio by 165% points. The greatest weakness of GWH Immobilien Holding GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 286% points.

The company's Economic Capital Ratio, given in the ranking table, is 186%, being 85% points above the market average of 102%.
