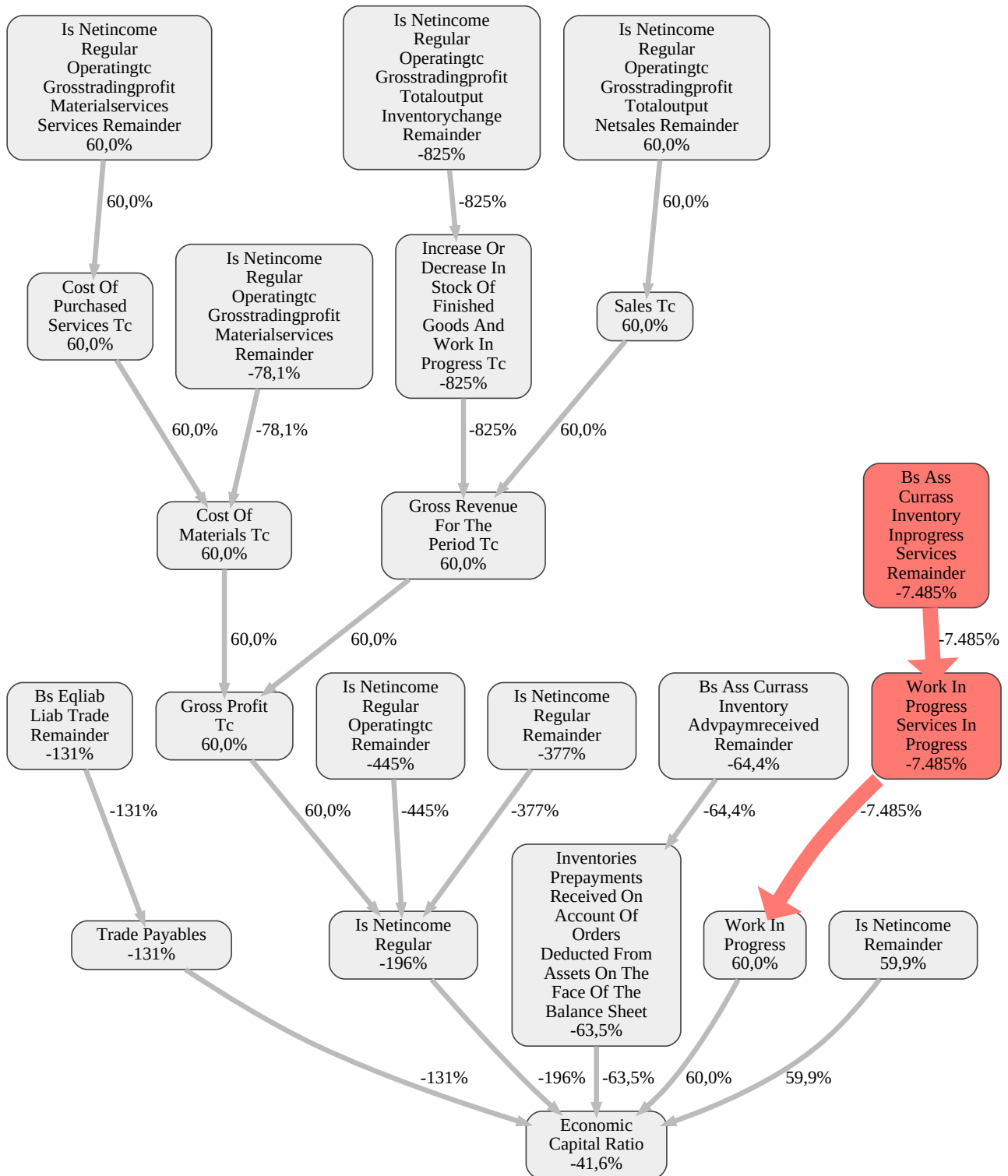




The relative strengths and weaknesses of ZECH Sports GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ZECH Sports GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 60% points. The greatest weakness of ZECH Sports GmbH is the variable Bs Ass Currass Inventory Inprogress Services Remainder, reducing the Economic Capital Ratio by 7.485% points.

The company's Economic Capital Ratio, given in the ranking table, is 60%, being 42% points below the market average of 102%.
