

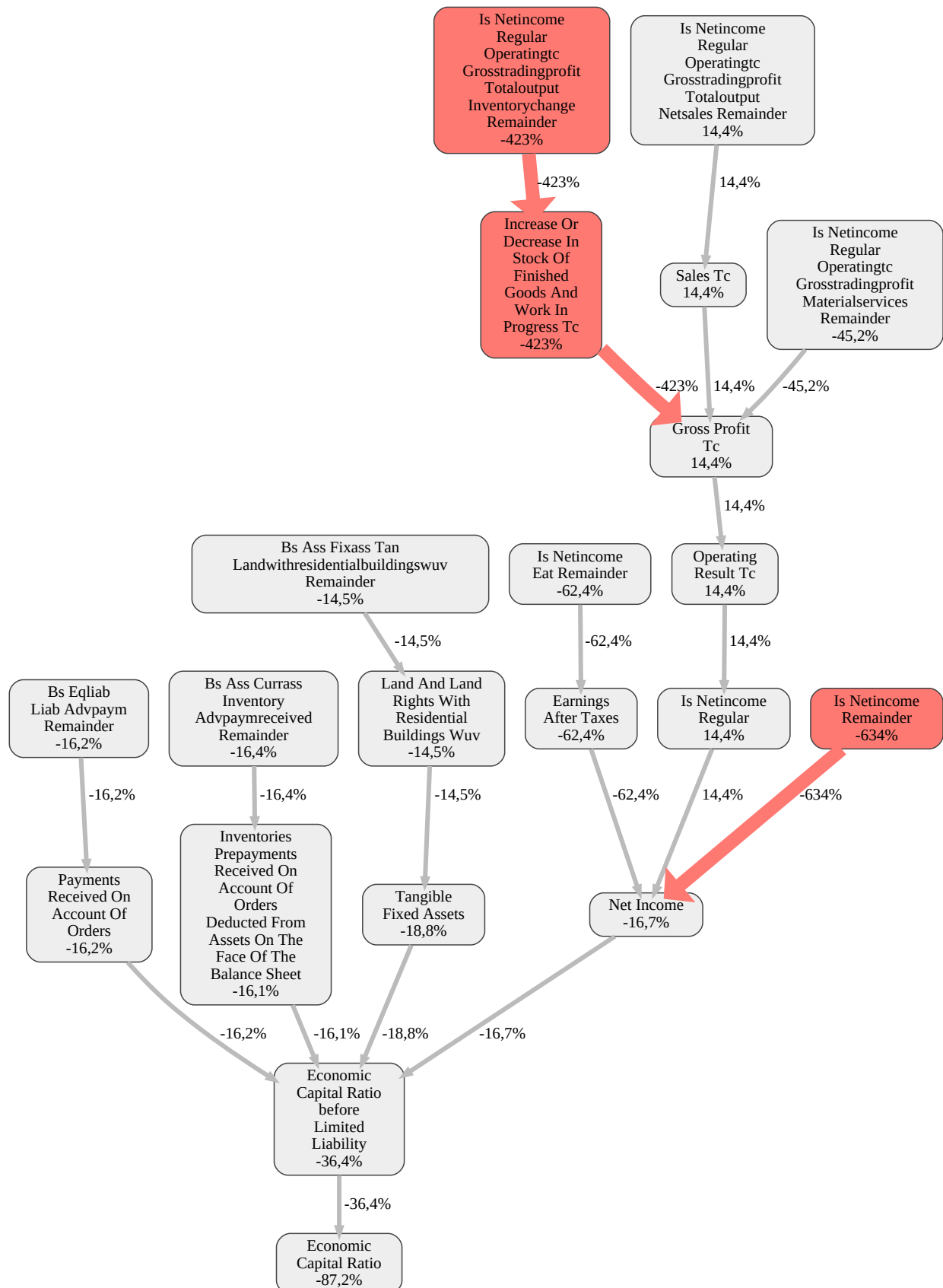

The relative strengths and weaknesses of Lindner Fassaden GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lindner Fassaden GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 14% points. The greatest weakness of Lindner Fassaden GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 634% points.

The company's Economic Capital Ratio, given in the ranking table, is 14%, being 87% points below the market average of 102%.
