



The relative strengths and weaknesses of Hofschröer Projektbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hofschröer Projektbau GmbH Co KG compared to the market average is the variable `Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder`, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Hofschröer Projektbau GmbH Co KG is the variable `Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder`, reducing the Economic Capital Ratio by 159% points.

The company's Economic Capital Ratio, given in the ranking table, is 56%, being 46% points below the market average of 102%.
