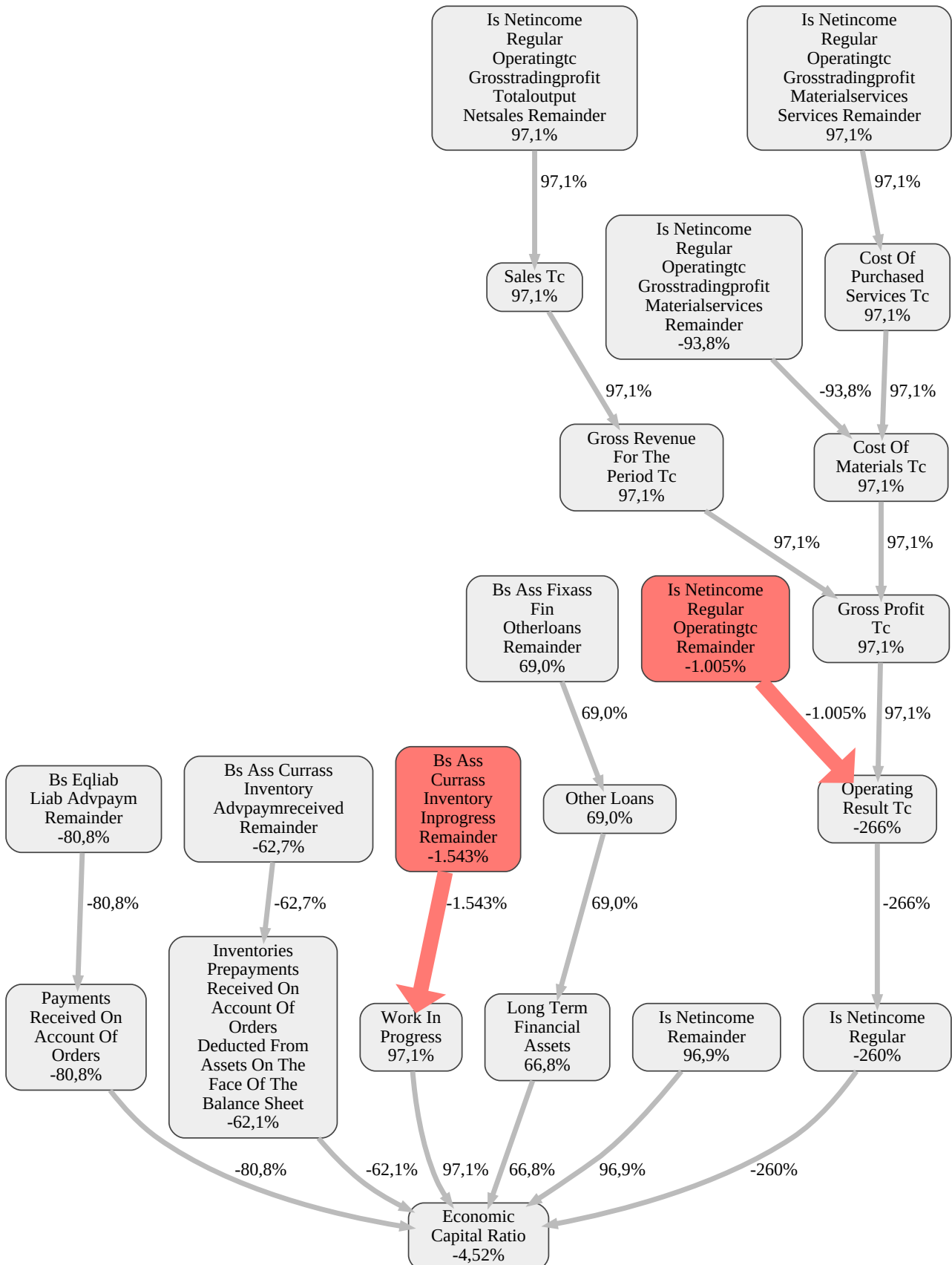




The relative strengths and weaknesses of Köster GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Köster GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 97% points. The greatest weakness of Köster GmbH is the variable Bs Ass Currass Inventory Inprogress Remainder, reducing the Economic Capital Ratio by 1.543% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 4,5% points below the market average of 102%.
